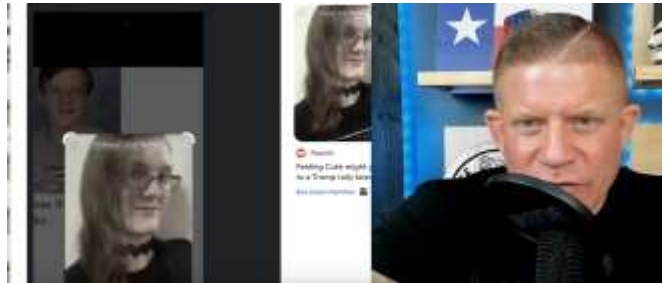

These stills are taken from a full video of Trump speaking by a person sitting behind him. These still photos show Crooks walking across the roof minutes before the shooting begins. ### Austin Private Wealth LLC

In the previous newsletter we covered the attempted and quickly retracted short put order made on July 12, the day before the assassination attempt by Austin Private Wealth LLC, for the purchase of 15 million shares of DJT Donald Trump stock.

Jesse on Fire makes a point that if you made a list of 100 global elite companies you thought would like Trump to be taken out because he poses a direct threat to their financial interests in the world, the list would most assuredly contain Blackrock, Vanguard, the Channey Family, the Soros Family and the Rothchild family. Those entities just happen to be the largest shareholders of Austin Private Wealth LLC. This is quite a coincidence.

It is estimated that in the attempted put option trade, had Trump died, his company stock would have become worthless and the put option order made by Austin Private Wealth LLC would have made hundreds of billions of dollars.

It has now been discovered that beside this put option order on Trump stock, Austin Private Wealth also placed put options on 36 million shares of Rumble stock (it is common knowledge that Rumble stock would have also plummeted if Trump had died).

With these put option orders, if Trump died, the Dow Jones and the NASDAQ would have crashed, and Austin Private Wealth would have made an estimated \$696 billion to \$1 Trillion in profits. That would have been the largest profit made by one company in a single order in all of history.

Stephen Gardner recently had Jovan Hutton Pulitzer on his show. Most people didn't pick up on that, and so I worried that something was wrong. I think they're going to try it again. I really do. I pray for the president, but I think they're gonna try it again. If they don't try it again, they're probably going to try something at the DNC and blame it on us. But we are getting more information and thank God for Twitter and Thank God for what Elon Musk did in opening that up. Because we can see with our own eyes.

But you know what. Here's the deal, folks. Don't worry if there was another shooter. You shouldn't be focused on a shooter, JFK style trying to solve this. You know you should be focused on why there so many failures allowed to happen. They're going to serve you little things to run in a rabbit hole. And if you let your mind get wrapped up with all the details such as the exact angle, the exact time and you add them all up to 137 divided by 21 you get etc., etc. Stop that crap. and the blood trail from his head goes another 30 feet down and off the building. You don't bleed out if it's a kill shot, there's no blood in a kill shot. That's how you know. How did he bleed out?



There is a steady line of blood from the body. And he was found 20 feet down from the crown of the building which he had to shoot from. And if he were shot in the head, there would be pinkish white stuff. Not red.

I'm looking at his teeth right incisors numbers 9 and 10 blown out. The shot did not come from the front, it came from the rear of Crooks. This is not where the two counter Sniper Teams were located.

One of the things I said earlier is we probably need to look for a “Malvo” type concealment and if you remember that was the DC sniper shooting through the keyhole of the trunk and they just laid in the car, removed the little badge on the car and shot through it and then covered it back and laid in the trunk. #### FBI immediately releases news that Crooks is lone shooter

On July 13, the day after the attempted assassination, the FBI announced on the news that the suspected gunman acted alone. This was announced even before the FBI even investigated Crooks’ car, his phone, his house and his background. Why would the FBI readily make such an announcement before they were even actually involved in the investigation and therefore impossible for them to know that? Was this announcement already pre-prepared?

### Continued evasiveness by the Secret Service

Dave Hodges shows Ted Cruz questioning the new director of the Secret Service Ronald Rowe (pictured above) about the actions of the Secret Service on the day of the attempted assassination.

Hodges who has degrees in psychology comments on how Rowe does not answer Cruz's questions and believes Rowe is a narcissist who thinks he can effectively evade questions under oath. But under questioning by Ted Cruz, Rowe was caught giving inconsistent statements.

Hodges comments that it is a common strategy for a security team who wants a person killed to simply compromise its own protection and allow actors to kill the person.

On the day of the assassination attempt, Rowe was in charge of the day-to-day operations of the Secret Service. Kimberly Cheatle who resigned was the head administrator in charge who allowed Rowe to run the operations that day.

On the stand under oath, when Cruz asked him if he had denied Trump a security detail, Rowe, lied and said he did not deny a security detail, when evidence shows he did.

There is now strong evidence to indicate that Rowe was part of a plot to purposefully weaken the security detail on that day.

Cruz asked Rowe, how many Secret Service members routinely protect Donald Trump and compare that to how many for Joe Biden and

Jill Biden (these numbers are known and are supported by records), Also how many Secret Services agents were there at the Butler site.

Rowe refused several times to answer this question saying a non sequitur that the president is the protector of the free world, etc. And Rowe finishes with I will have to get you the answer later.

The Secret Service counter sniper on the roof behind Trump allegedly issued a message that appeared on 4chan stating he had the assassin in his sights but the head of the Secret Service refused to give the order to fire. It has been reported this person Jonathan Willis is no longer in the Secret Service.

The acting director of the Secret Service Ronald Rowe says he is ashamed that his agency allowed a 20-year-old gunman to climb on top of a warehouse roof and fire eight shots at Republican front-runner Donald Trump. "I went to the roof of the AGR building where the assailant fired shots, and I laid in a prone position to evaluate his line of sight," he told Congress on July 30. "What I saw made me ashamed as a career law enforcement officer and a 25-year veteran with the Secret Service. I cannot defend why that roof was not better secured."

Despite his shame, Rowe and his agents are doing everything in their power to stonewall Congress and make sure the American people never find out the truth about the attempt on Donald Trump's life.

Newly released testimonials from before and after the Trump assassination attempt highlight catastrophic lapses by the Secret Service and local law enforcement. Acting Director Rowe has admitted that not placing a Secret Service agent on the roof of the American Glass Research warehouse was a huge mistake. Yet an even bigger

“mistake” was not putting local police in direct radio contact with Secret Service agents. Rowe told Congress that his agents were not notified about the shooter until after the attempt on President Trump's life, even though local law enforcement were aware of the danger at least 90 minutes before President Trump even began speaking.

The alleged miscommunication was apparently the result of a siloed communications system in which local officers reported to local command, who relayed messages to the Secret Service. This might have been partially responsible for why Thomas Crooks had so much time to get into position on the roof and start shooting, even after a local police sniper called into his command to report Crooks as a potential security threat. Who decided to silo communications this way? Acting Director Rowe is not answering questions like that. Secret Service Director Kimberly Cheatle resigned over these same security failures that Rowe says he is ashamed of, but neither one will divulge who is responsible for allowing a suspicious figure to not only remain in the vicinity but spend almost half an hour on a roof overlooking President Trump only 500 feet away.

Some might say that Cheatle and Rowe are being noble by protecting the reputation of the agents who messed up at the Butler Farm rally. But a closer examination of the facts suggests a more sinister motive. Nothing that happened at Butler Farm makes sense unless someone on the inside wanted Trump dead.

The Secret Service is doing its best to make sure people never find out who that person is. Instead, it is working with the FBI to convince Americans that Thomas Crooks was somehow a lone-wolf shooter with anti-immigrant views who tried to kill Trump because he was not conservative enough.

FBI Deputy Director Paul Abbate told Congress that Crooks made anti-Semitic and anti-immigrant statements on social media. This was a lie. The CEO of Gab, Andrew Torba, has access to the same Gab social media account that Abbate referred to in his testimony. Under the handle @epicMicrowave, its user expressed pro-lockdown, pro-immigration, pro-Biden sentiments. In a post to X on July 30, Torba clarified that “the account for which data was requested was, unequivocally, pro-Biden and in particular pro-Biden's immigration policy. To the best of Gab's knowledge, as of 2021, Crooks was a pro-lockdown, pro-immigration, left-wing Joe Biden supporter.”

So why is the FBI trying to make “a pro-lockdown, pro-immigration, left-wing Joe Biden supporter” look like someone so racist and so “conservative” that he felt President Trump was insufficiently “extreme”? Could it be that Crooks actually had help from a fellow “pro-lockdown, pro-immigration, left-wing Joe Biden supporter” within the Secret Service? Could it be that the Secret Service and FBI are trying to cover up a scandal by making it an open-and-shut case that Crooks was just weird and, by the way, conservative.

That is a disturbing notion, but it is not far-fetched, because anyone

who reads the post on the @epicMicrowave account can see that the FBI is deliberately lying about Crooks's motives for some reason.

A RealClearPolitics exposé by Susan Crabtree reveals that Acting Director Rowe was directly involved in denying additional security resources and personnel to President Trump's rallies and events. Inside sources told Crabtree that it was Rowe's decision alone to deny counter sniper teams to any Trump event outside of driving distance from Washington, D.C. The reason that the American Glass Research buildings, including the one Crooks used, were apparently assigned to local police in the first place is that Rowe declined to provide sufficient Secret Service personnel.

So we know that the Secret Service denied resources and personnel, and we know the FBI is boldly lying about Crooks's political motivations.

Now a Secret Service countersniper has mass e-mailed much of the agency warning that a second assassination attempt against Trump is almost inevitable before the 2024 election because “[w]e've exposed our inability to protect our leaders due to our leadership.” This agent, many others and many Americans don't believe Secret Service leadership will successfully prevent—or perhaps even try to prevent—the next attempt to kill Donald Trump.

Sen. Josh Hawley directly asked Rowe whether any of the agents responsible for monumental security failures at Butler Farm had been relieved of duty, and Rowe confirmed that the answer is no. He instead blamed the security failures on the local police, while knowing full well that he himself had starved Trump's security detail of resources and manpower.

It's apparent the FBI is hiding something and that Rowe and the still -anonymous and still-employed Secret Service site manager are the two people most to blame for the security arrangements and miscommunications. The local police did their job by spotting Crooks and calling it in to command. But the siloed communication system the Secret Service set up delayed instructions by half an hour, giving Crooks time to get set up and shoot.

On August 17, both the Full Spectrum Survival and the Stephen Gardner Show reported that the FBI secretly cremated the body of Thomas Crooks.

Both shows reported that on July 27, ten days after the shooting, the FBI cremated Crooks's body destroying all evidence of the bullet wounds and how he was killed. The information of the cremation was not released until Aug 5. A second autopsy was scheduled to be made soon thereafter but is now rendered impossible. Now we will never know how Crooks was killed and from where the bullet that killed him came from. Also, it was reported that within a few days after the shooting the roof where Crooks's body lay was washed clean of evidence.

Why did the FBI do this?

There are also photos of Thomas Cook's bicycle parked near the AGR building.



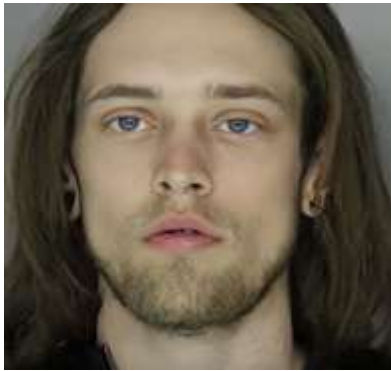

can't confirm very much information about Maxwell Yearick, but let me just share what little information has been reported on him. The white van is tied to a company in Mesa, Arizona called Yearick Armory.



This company manufactures explosives and has a history of allegedly selling goods to guerrilla groups in Peru and Colombia with the help of the CIA. Yearick has been allegedly involved in Antifa protests in Seattle, Pittsburgh, Washington DC, Portland, Minneapolis, Chicago, New York, Los Angeles, Atlanta and Boston. Why isn't anyone in the news looking into this guy?

What is also odd is the dead body on the roof looks more like Maxwell Yearick than it does Thomas Crooks.



Just at first glance, you can see a scar on the dead body’s ear where he previously had gauges in his ear that were sewn up.

Maxwell Yearick had gauges in his ear,



whereas Thomas Crooks did not. I would like to know why the FBI has given no explanation as to why the dead body had scars for gauges in his ear, while Thomas Crooks had no gauges in his ear. Why haven't they explained this?

There are also images that look like the dead body has a tattoo on his arm.



Maxwell Yearick had a tattoo on his arm, whereas Thomas Crooks did not have a tattoo.



Some people will say well that's just dirt on his arm. I'm sorry, but you don't get dirt on the inside of your elbow. Where did the dirt come from? Was he down on the ground, rolling in the dirt before he got up on the roof and shot at Trump? That doesn't make any sense. Now let me be clear. Law enforcement has officially identified the dead body as Thomas Crooks. But if that's the case, how do you explain the white van from Arizona full of explosives. How did a van from Arizona get to Pennsylvania? Why isn't anyone asking any questions? It certainly makes me question the lone gunman theory.

### 2) The Cremated Body

There is a shocking development happened this last week when it was discovered that the body of Matthew Crooks is gone. Representative Clay Higgins has been doing his own investigation into the shooting.



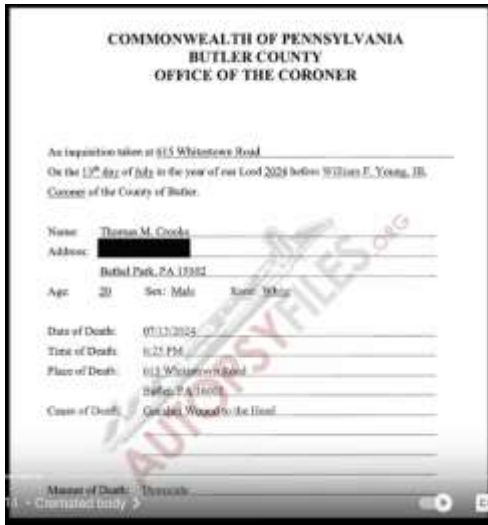
When he went to go inspect the corpse, he was told "what do you mean, you want to see the corpse? The corpse is gone. The FBI sent the body to be cremated only 10 days after the shooting. The FBI are the only people who were able to examine the body. Since the body is now cremated, there is no way to verify if the body was in fact Thomas Crooks or Maxwell Yearick, other than take the FBI's word for it. This looks like the FBI released the body for cremation as a way to destroy evidence and cover up any following investigation. The FBI has responded and said that is not the case. They claim they followed every procedure by the book. That's a little ridiculous. Why didn't they tell anyone before destroying the body? Nobody else knew the body had been released for cremation, including the county coroner or the sheriff. Why would the FBI do this in secret when they knew that Congress was holding their own investigation?"

What is also odd is that the autopsy report has yet to be released. This is all that has been released.

#### 3) Redacted sign in sheets.

Senator Grassley was performing his own investigation



and uncovered these sign in sheets for the gun range where Thomas Crooks was practicing in the months before the shooting.

It is one page that shows Thomas Crooks died to a gunshot wound to the head. Where's the rest of the report? What procedure was done to identify Thomas Crooks? Did they check his dental records? Did they have an explanation for the scars on the ears? This is all very strange. Why is it that all the evidence that could have supported the FBI story has been destroyed? Now we just have to take the FBI's word for it.



Even more strange, the FBI released the crime scene only three days after the incident. They washed all the DNA evidence off of the roof so no one else could inspect it.

This is a gun range that was used for training by DHS and the FBI. All the names are redacted except for Thomas Crooks.

However, there are four instances where another person signed in at the exact same date and time as Thomas Crooks.

Did the DNA belong to Thomas Crooks or Maxwell Yearick? I guess we'll never know. Another example where we will just have to take the FBI's word for it.

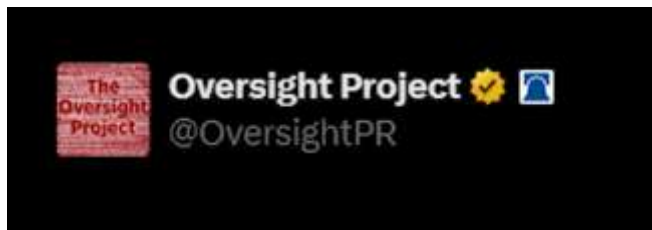

The name is redacted, so we don't know who this is. Who is this mysterious person who has repeatedly shooting with Thomas Crooks? Don't you think that would be important information? Why can't we see the name?

### 4) Cell Phone Data

Using cell phone data, the oversight project tracked multiple cell phone devices that were present at Thomas Crooks home address.



The data shows that someone who regularly visited Thomas Cook's home in Pennsylvania also visited Washington, DC near an FBI office.



Who is this person? And why would they go back and forth between Thomas Cook's house and the FBI offices? Is this the same person who was signing in with Thomas Crooks at the gun range where the FBI practices? I'm beginning to think maybe he wasn't a lone gunman.

### 5) Location of the Gun

One of the first things that raised questions for me was the location of the gun. Here's a photo of the dead body on the roof.



Does anyone notice anything strange? The gun is located what looks to be 10 feet away from the body. How did that happen? If the shooter was holding the gun when he was shot, wouldn't the gun be underneath him? How did the gun get all the way over there? Did he throw the gun? Did someone move the gun after he was shot? Was someone else there actually doing the shooting? If the shooter tried to crawl away from the gun after being shot, why is there no blood by the gun. No one has been able to provide any explanation as to why the gun is so far away from the body.

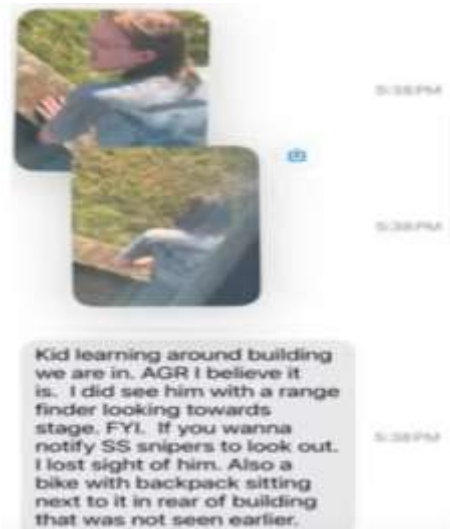
### 6) Secret Service text messages

A shocking text message between Secret Service agents was released. This is from one agent who was leaving from an earlier shift who saw Thomas Crooks in the parking lot.



He says “someone followed our lead and snuck in and parked by our cars. Just so you know, I'm just letting you know because you see me go out with my rifle and put it in my car. So he knows you guys are up there. He's sitting to the direct right on a picnic table about 50 yards from the exit.” The agent responds with a thumbs up emoji and Roger that. This text was sent at 4:26 PM showing that the Secret Service knew there was a threat from Thomas Crooks over 90 minutes before the shooting. That's even earlier than we previously thought. It also shows the Secret Service themselves were aware and acknowledged the threat. They can't say that the information didn't get to them. So why did they let Donald Trump get on stage with a threat in the crowd? If they had 90 minutes to neutralize the threat, what took them so long? This is supposed to be the best security force in the world. What are they doing?

But the text messages get even worse. Here are photos taken of Thomas Crooks at 5:38 PM by one of the Secret Service counter snipers.



He said “kid lurking around building. We are in a GR. I believe I did see him with a range finder looking towards the stage. FYI, if you want to notify Secret Service snipers to look out. I lost sight of him, also a bike with backpack sitting next to it in rear of building that was not seen earlier.”

I don't even know where to begin. The sniper saw him, took pictures of him, saw him looking at the stage with the range finder and they still didn't stop this guy.

But it's even worse. The location of this photo was taken from is inside the same building that Thomas Crooks fired from. Yes, the Secret Service snipers were inside the building while Thomas Crooks was on the roof. Let me explain the layout of the site. Here is the roof where Thomas Crooks. was laying down.



Here's the stage where Donald Trump was speaking.

There were Secret Service snipers on both of these roofs.

So going back to the photo the sniper took on his phone. Thomas Crooks is sitting on a wall. That wall is right here.



It is still incredible to me that no snipers were stationed on this roof.

The sniper is looking down from this window.



Director Cheadle claimed the reason was because the slope was too steep. Instead, the snipers were stationed on the 2nd floor inside the building. Right here, they were right there.

Now the snipers claim that from this window they could not see where Thomas Crooks was laying down on the roof. But why not look out this window or this window.

I don't believe that the Secret Service didn't walk around the floor and lookout the other windows. In fact, we have video from the other windows. They could have literally opened the windows and climbed onto the roof. Thomas Crooks was in plain sight of those other windows.



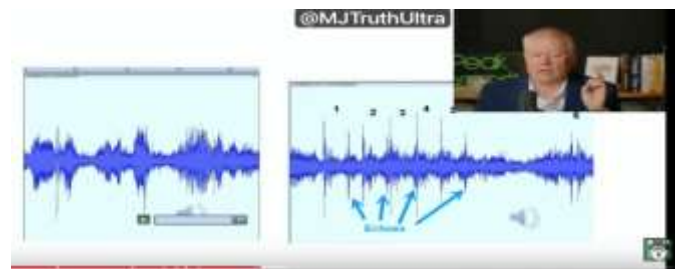
What is even crazier is what happens next. The same sniper who took those photos from the window conveniently decides to leave his post right before the shooting started. At 6:06, he decides to move to the ground floor to find a local police officer to alert them about Thomas Crooks. At 6:11, the shooting started. This is a sniper whose sole job is to protect Donald Trump during his speech. You're telling me that he decided to leave Trump unguarded during the speech to go report a threat? What about using a radio? Something does not add up.

### 7) Audio of gunshots

I covered this in my last video. You can listen to the audio from the rally and tell a lot about the gunshots. You hear the same thing in all

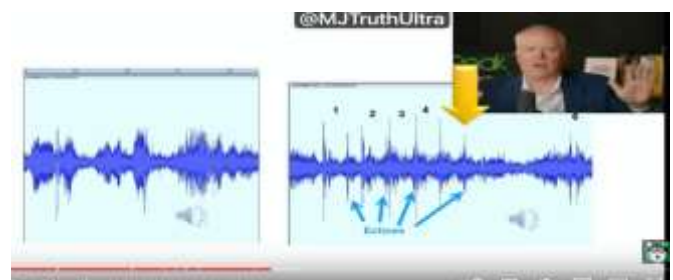
the different camera angles that were shot at the event.

Sound analyst talking: "We just have an absolutely different sound between the 1st and 3rd shot. There's no echo, it's much further away. It's more muffled. It's just not in the same place at all. But these next ones, very different sound. Totally different weapons. OK. Full stop. We have two separate weapons. Plus, we have no echoes coming off of the 1st 3 shots and then we do have echoes coming off of the next set."

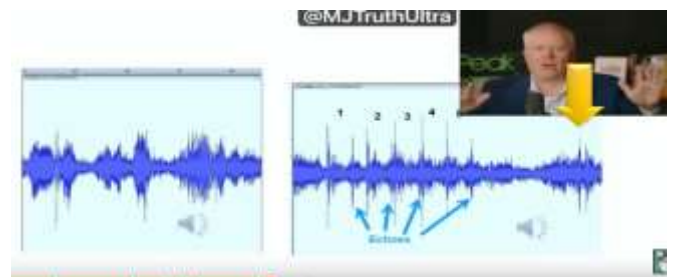


So there are three shots to start, and then five more. And they sound like they are clearly coming from different weapons and different locations. Let me repeat. You can hear this difference in all the different videos of the shooting. Audio does not lie. I don't see any way that these gunshots sound like they are coming from a lone gunman.

So there are eight shots, then one more here that stops the shooting.



And then the final one here,

which was the death blow from the Secret Service sniper. What's interesting is the shot before the last was from a local SWAT police officer. While the other Secret Service agents were covering behind Trump this police officer ran into the line of fire as soon as the shooting started. He drew his weapon and fired, damaging the rifle, which stopped the shooter from continuing. It was only after this that the Secret Service fired and killed the shooter. This begs the question, why didn't the Secret Service fire first? What were they waiting for?



### 8) The Water Tower

There has been a lot of discussion that there was a second shooter from the water tower. This is zoomed in from the live stream at the rally. This appears to be a man standing on top of the water tower while the shooting is in process.



Personally, I think this is very convincing, but some people argue that this was just a visual glitch or a shadow. I think it's important to realize that this video is not where the water tower theory started. It started because people at the event were claiming the shots were coming from the water tower. Keep in mind that some of the people at the event were veterans and have experienced being under fire and determining where bullets are coming from.

Attendee "This crack of the gunfire and I just screamed. It's the sniper. It's the sniper and he was firing down toward the water tower"

There are three eyewitness accounts all saying that there was a sniper on the water tower. Now it is possible they were confused, but I think that someone should climb up there and check it out. But for some reason the FBI will not let anyone up there.

Congressman Clay Higgins has been performing his own investigation.

He went out to the location and then wrote a report supporting the lone gunman theory. He wants people to stop talking about the water tower. He says "if there had been someone on that tower on July 13 it would have to have been some top shelf operator way beyond anything I've ever actually seen. Regular SWAT operators or snipers would not have the skills and gear to quickly overcome the first 25 feet of no ladder and then climb the remaining 75 feet to the catwalk and then climb the quite intimidating and precarious dome vent access ladder."

Really, Congressman, you don't think that any of our special agents could handle climbing a water tower? I find that hard to believe. Why is this congressman trying so hard to convince people to stop talking about the water tower?

An interesting fact you should know is that on the day of the shooting the water tower was guarded by two local cops. Now get ready for this. These two cops just happen to leave their post one hour before the shooting. Isn't that convenient? Why are all these people leaving their post at the exact right moment? The sniper in the HR building left his post just before the shooting. Now these police officers left their post right before the shooting. I want an explanation of why these cops left their post.

Now the congressman wrote his report without actually climbing the water tower himself. It was blocked off and no one would let him climb up there. Why is everyone being kept away from this water tower? Isn't that strange?

What is disturbing to me is that you can see in this video that the water tower is being blocked off.

Why are they treating it like a crime scene? Here's a photo of the site layout. The shooters body was found here.



It would explain the different audio if some of the shots came from the water tower and others from the roof.



Here's another video taken from before the rally started. The driver was driving past the site and captured this photo. If we freeze the video we can see a truck beneath the water tower.

Donald Trump is on stage here,



so the water tower is coming from a similar angle and can hit all the same shots.

This doesn't look like a police vehicle to me. It looks more like a government vehicle.



Who was at the water tower? There's someone on YouTube named Black Gen. Z. Mindset and he went on Google Earth and found that nearby the water tower there's an entrance to the sewer system. This YouTuber might have just figured the whole thing out. There is a sewer manhole near the base of the water tower.

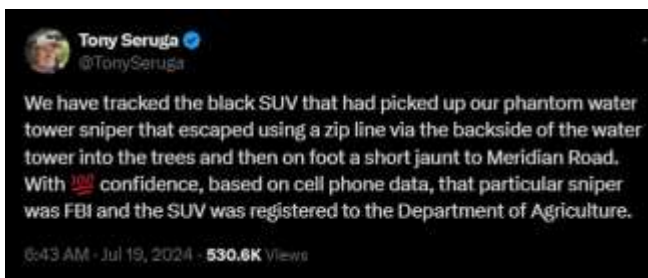


He could have come out of the manhole, climbed the water tower, shot at Trump, then climbed down and escaped through the man hole cover (bottom right hand corner of photo below) through the sewers.



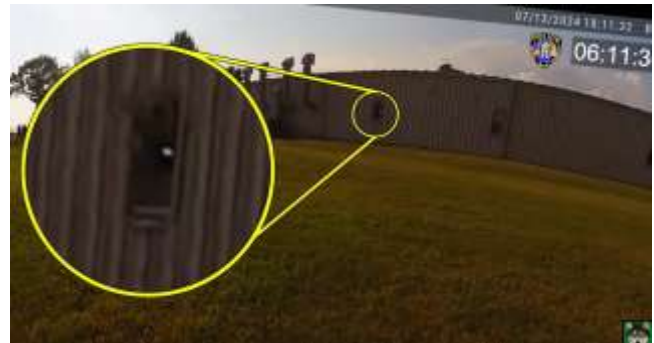
But escape through the sewers is not the only option.

Here's a tweet by Tony Seruga saying we have tracked the black SUV that had picked up our Phantom water tower sniper that escaped using a zip line via the backside of the water tower into the trees and then on foot. A short jaunt to Meridian Rd. with 100 confidence based on cell phone data. That particular sniper was FBI, and the SUV was registered to the Department of Agriculture.



Now, Tony Seruga has not provided the data to back up these claims. So I cannot verify if they are true. We don't know if the shooter went through the sewers. We don't know if the SUV picked him up. All I'm saying is that there's enough eyewitnesses that saw something happen at the water tower that someone should go investigate. But instead, they're not letting anyone up there.

The water tower is not the only possible location. If we look at video of the AGR building at the exact moment of the shooting. We can see what looks to be like a muzzle flash coming from one of the first floor windows.



People have criticized this as potentially just a reflection from the glass in the window. Another potential location is the Butler Gymnastics Club, which is another nearby building. That was also not being watched by Secret Service. It could also match the trajectory of the bullets. Here's where Trump was.

Here's the water tower.

Whatever the location was, you have to start asking the question why were there so many possible locations where people could shoot at Donald Trump?

#### 9) The 8 Shell Casings

The reason the FBI gives that this was a lone gunman is they claim to have found all 8 shell casings they allege were fired by Thomas Cook's rifle. They claim this means that all shots are accounted for and they all came from Thomas Crooks. There could not be a second shooter because the FBI has the shells. But here's the problem. The FBI has not let anyone else inspect the shells. That's strange. For all we know, the FBI could have placed those shells at the crime scene. Here's my problem with the FBI story. If the FBI is telling the truth, the police body cam footage should confirm their story. We should be able to see the shells on the roof. Now, I've spent a lot of time going through the body cam footage and it's not as straightforward as you would think. I'm going to show you something that I don't think anyone else has noticed.

Here is the body cam of the police counting out the shell casings on the roof. The officer counts 5 shell casings.



He points out five shell casings, but there were eight shots. Where are the other 3 shell casings?

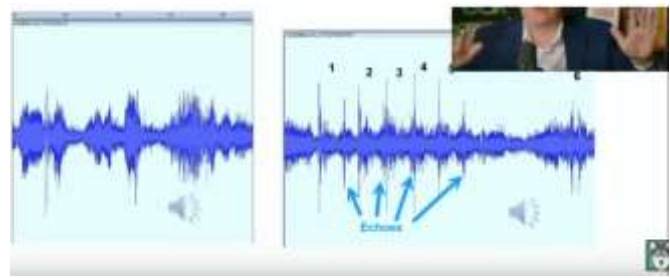
There's nothing else on the roof, so we should be able to see them quite easily. About 20 minutes later in the body cam footage, this same officer counts a second time. He now counts out 8 shell casings.

Why did he count five the first time and eight the second time? His body motion tells us that three of the shells were much farther away from the body. That's strange. Every time a gun fires, the shell ejects and lands on the ground next to the shooter. It's very predictable to tell where the shells will land based on the location of the shooter. Now maybe the cop just didn't see the shells the first time he counted. But I found it very odd that he specifically counts 5 shells and then after a break in the video he later counts another three. This matches the volleys of shots. There were three shots, in the first volley and then a second volley of five shots. That's a pretty strange coincidence. Now, I'm not saying this cop screwed up. I think he had two different counts of the shells because three of those shells weren't where they were supposed to be. So then the FBI comes in later and says we have 8 shells, so there's only one shooter. We're going to need a better explanation than that. There were a lot of people on that roof. How do we know that someone didn't place those extra 3 shells after the fact? And why aren't those 3 shells in the location they're supposed to be? I would like to see the FBI do a test. Someone should replicate the shots with the rifle and see where the shell casings fall. Because I'm betting that they fall in a different location.

Let me provide another explanation. The first volley of three shots that fired on Trump could have come from a separate location like the water tower. The 2nd volley of five shots could then have come from the roof of the HGR building. Someone could have placed three extra shells on the roof after the fact. That would match what we see with the five shells from the first count in the body cam footage, followed by three more shells in the second count. All of this also matches what we heard in the audio.



I think we need to ask the FBI why won't they let anyone inspect any of those shells? Like everything else, we're just supposed to take their word for it.

10) The detonator.

Another major question that has never been answered is about the detonator.



Thomas Cooks had in his possession an electronic transmitter. There are two explosive devices in his car. Director Wray testifies they recovered 3 explosive devices, two in his vehicle and one in his residence. I believe the FBI here is referring to the Hyundai Sonata as the vehicle. The FBI has said that they found no Internet searches by Thomas Crooks on how to make an electronic transmitter. This is a huge question. How would Thomas Crooks know how to make explosives unless he was working with someone else. For an electronic transmitter to work he would need a blasting cap. You can't just go out and purchase a blasting cap. They're regulated by the ATF. So that means he would need to make one. He would need a massive, smelly chemistry lab at his home to manufacture a blasting cap. It doesn't sound like he had that. So where did he get a blasting cap and transmitter? For that matter, how did he know how to make

these explosive devices without doing any Internet searches? This is more evidence that he was not working alone. Someone showed him how to make those explosives. How come no one in the news is trying to figure out who that was?

### 11) The phone call from the father

On the day of the shooting, Thomas Cook's father called the police.



This has always been a problematic part of the story. Here's the official story, as reported by the BBC. Thomas Crooks' father called police because he was worried about his son and his whereabouts. It's unclear when the call was made, but it was before the shooting. So the timeline goes something like this. In the morning, Thomas Crooks asked his father if he could borrow his AR15 style rifle and went to the shooting range. The father thought his son would return home around 1:00 PM. When the son did not come home, the father called the police. Now if this phone call occurred sometime before the shooting, it would have been between 1:00 PM and 6:00 PM. That's a 5 hour window. Now let me ask a question to any parents out there. If your son was late coming home on a Saturday afternoon, would you call the police within the first five hours? I can't imagine why anyone would do that unless something else was going on. Did the parents have reason to believe he was going to cause violence at the rally? What did they say on that phone call? I am also interested if the parents know who the second person was who traveled from their house to the FBI office in Washington DC.

Now if the parents called the police, that phone call would have been recorded. But what is very strange is that when people have done information requests with the police department, the police claim that the recording of the phone call does not exist. It sounds like the phone call is being covered up. Why? What did they say on that phone call? What is also disturbing is that this is not the only record-

ing that doesn't exist.

In his testimony to congress Director Ronald Rowe's said the Secret service has no recordings of the conversations on the day of the shooting. He said it is unfortunate that they did not make recordings but they will now begin to make recordings.

The Secret Service has no recordings of their communications. Why does everything seem like a cover up?

Let me give my own explanation of the phone call from the father. Now I can't confirm any of this, but it's the only explanation that I think makes sense. Thomas Crooks probably bragged at home that he was going to go to the rally to shoot Donald Trump. The father probably only agreed to let him go to the gun range if he would come back home by 1:00 PM before the rally started. When his son did not come home, the father became worried and called the police. That means the phone call to the police was a tip that someone was on their way to the rally to shoot Donald Trump. If the police had this tip, why would the Secret Service allow Trump to go on that stage? Unless there's a traitor within the Secret Service.

### 12) The Men in the Grey Suits

There has been confusing video showing men in grey suits involved in the investigation immediately following the shooting. Here is one man in a grey suit at a Jeep.



Here's another man in a grey suit talking to law enforcement.

Who were these random people in grey suits?

News anchor talking: "The local officers went up to that roof and started taking pictures of the dead body of the shooters body. So suddenly a guy in a grey suit walks up the ladder and goes up to the roof. And this guy in the grey suit, who didn't appear to have credentials, everybody assumed he was the Secret Service. So he tells one of the local law enforcement send those pictures to this cell phone and he gives them a number to send. Everybody assumed that must be Secret Service. It turns out it wasn't Secret Service."



This is weird, so apparently the man in the grey suit asked the police to text photos of the body to someone at ATF, The Bureau of Alcohol, Tobacco, Firearms and Explosives. What does ATF have to do with anything? Who were these men in grey suits and why were they randomly at this particular Trump rally? And why did no one in law enforcement question the men in grey suits giving orders at a crime scene? They're ridiculous orders and it seems more likely it was just an excuse to get on the roof. Here's the real question. Was the man in the grey suit standing anywhere near where the mysterious 3 shell casings were found? This is very strange and so far the FBI has not given anyone an explanation for this. Who were the men in the grey suits?

### 13) People acted like they knew before what was going to happen

One of the most concerning things is that it seems like people knew that something was going to happen before the shooting even took place. In an interview one week before the shooting, Director Cheadle talked about the Secret Service being ready to counter both lone shooter incidents and organized attack incidents. You have to admit that's strange timing.



Then there was this interaction with Senator Joe Manchin talking about Joe Biden the week of the shooting.



Manchin was asked if he were confident about Joe Biden being up to running in the election. Essentially Manchin says he was confident about Biden and that if you just wait this weekend there will be more coming out.

What is that mean? He says if you just wait until this weekend, there'll be more coming out. What did he know about what was going to happen? That's kind of a strange thing to say.

Then there is this interview with Victoria Newland.

In case you don't know who she is, she was the former national security adviser to Vice President Dick Cheney. She worked in government during the Clinton, Bush, Obama and Biden administrations. She left government during the Trump administration. She's married to Robert Kagan who is one of the main instigators for George W Bush and his war in Iraq.



Victoria Nuland was one of the primary instigators for the current war in Ukraine. This is someone who has been deeply involved in CIA operations around the world for the past four presidents, except for Donald Trump.
