THE FINDINGS OF DOGE

The Department of Government Efficiency (DOGE), led by Elon Musk, has been investigating alleged economic waste. ELON MUSK HAS PREDICTED, "AS IT BECOMES CLEAR THAT DOGE IS WORKING, YOU WILL SEE THE LONG-TERM TREASURY BILL YIELDS FALL. ALL AMERICANS WILL BENEFIT FROM LOWER INTEREST PAYMENTS ON MORTGAGES, SMALL BUSINESS DEBT, CREDIT CARD AND OTHER LOANS."

But first, here is a little DOGE trivia.

The Democrats are complaining that the inves

tigations by DOGE are infringing on the privacy rights of the agencies they are investigating.

But did you know that the authority for DOGE was originally created by President Obama to support his Obama Care program?

The genius of the Trump people is that they simply are using the apparatus and legal authority set up under President Obama back in 2014 when he created the US Digital Services (USDS) Act, which was a bureaucratic patch job to fix the Obama Care website.

Trump invoked 5 USC 3161 and created temporary hiring authority to create DOGE teams. DOGE teams got embedded into every single Federal Agency. Each team consists of a lawyer to keep things constitutional and legal, a Human Resources individual to protect the job rights and pension rights of people who can come under scrutiny, a tech specialist who can bypass passwords designed to keep them, and an investigator who knows what they are looking for. That is a DOGE team, and they report to the President or his designee.

Trump invoked 44 USC Chapter 35 which governs Federal information technology and security oversight over materials. The USDS was originally an oversight body created by Obama. This same authority is the basis for DOGE. The USDS has the same acquisition abilities as what Trump wanted to do when he issued the executive orders to create DOGE.



OBSERVATIONS

Now two judges have ruled that it was President Obama who originally created the authority for DOGE, not President Trump. The judges ruled that President Trump with DOGE is only investigating what already is, he is not exploring agencies without a specific goal as it would be under a general services warrant. The judges said with USDS, President Obama created the precedent to investigate what DOGE is searching for now. President Obama opened the door to help his Obama Care and president Trump is walking through the door. Trump's people were brilliant to find this advantage and use it.

DOGE sent emails to federal government workers asking them to list their weekly accomplishments or risk being terminated. Many workers vehemently responded with defiance. Does this suggest objective overreach by DOGE or a latent sense of entitlement by government workers?

Here are just some initial findings of DOGE up to now. **It is certain more disclosures will be forthcoming in the future. The complete findings by DOGE may likely disclose to the world the largest fraud ever perpetrated by a government in the history of the world. We shall see.**



U.S. Agency for International Development (USAID)

Musk has publicly criticized USAID, calling it a "criminal organization" and advocating for its dismantling

The DOGE team has highlighted several projects funded by USAID as examples of waste, including:

\$1.5 million to advance Diversity, Equity, and Inclusion (DEI) in Serbia's workplaces

\$70,000 for the production of a DEI musical in Ireland

\$47,000 for a transgender opera in Colombia

\$32,000 for a transgender comic book in Peru

The White House has cited these projects as examples of wasteful spending

The DOGE's actions have been met with significant opposition, including legal challenges and protests from Democrats and federal workers' unions

A federal judge has temporarily blocked some of DOGE's orders, preventing the immediate placement of over 2,000 USAID workers on administrative leave

It's a contentious issue with strong opinions on both sides. But most Americans are saying it's about time!



US Treasury

DOGE has discovered that in the US Treasury, \$4.7 Trillion dollars is unaccounted for. There is NO record of where this money went. And no one seems to know where.



DEI

There were significant cuts to Diversity, Equity, and Inclusion (DEI) programs such as:

Termination of DEI Training Grants: DOGE terminated 29 DEI training grants worth a total of

\$101 million

These grants included programs aimed at training teachers to help students understand complex histories of oppression and recognize areas of privilege and power

Elimination of DEI Contracts: DOGE also ended several DEI contracts, including one worth \$36,126 for training leadership and supervisors at U.S. Citizenship and Immigration Services (USCIS)

Virtual Reality DEI Program: One notable contract that was cut was a \$2.3 million grant for a virtual reality DEI training program at the Air University at Maxwell Air Force Base

Public Relations Firm Contract: The U.S. Patent and Trademark Office had a \$2.86 million contract with a public relations firm for the Council for Inclusive Innovation, which aimed to increase participation of underrepresented groups in innovation

These cuts have sparked a debate about the impact on marginalized and underrepresented groups, with critics arguing that they could hinder efforts to improve education and workplace environments



Department of Defense (DOD)

The DOD paid \$32,000 to replace 25 coffee cups and hundreds of thousands of dollars for soap dispensers.

Of a selected 46 spare parts, they found the Air Force overpaid about \$1 million for 12 of them for its C-17 transport planes.

The Air Force was spending \$1,300 for each re-heatable coffee cup on its KC-10 aircraft and then replacing them instead of repairing them when the handles broke.

Social Security

In the Social Security files they found there were 395 million active Social Security Records. Currently, there are 365 million Americans in the country. 20 million of the records are of people over the age of 100. 15 million of the records are of people over the age of 110. Perhaps many age records have now been broken.



GAO

The GAO records show 18 agencies reported an estimated \$247 billion in improper payments across 82 programs. Approximately 78 percent of this total (about \$194 billion) was reported by five programs areas (1) Medicaid (\$81 billion), (2) Medicare (\$47 billion), (3) the Paycheck Protection Program (\$29 billion), (4) Unemployment Insurance (\$19 billion), and (5) Earned Income Tax Credit (\$18 billion)



FBI

The Senate confirmed Kash Patel as the new FBI director. This appointment promises to change the FBI's culture more than it has since Edgar J. Hoover founded it. During the prohibition era, the FBI had a moniker, the Untouchables. Under Patel, will this moniker be resurrected? Dan Bongino, former New York City police officer, Secret Service Agent turned conservative pundit and podcaster was appointed deputy director of the FBI.



Fort Knox

There will be an audit of the gold in Fort Knox soon. The last time an audit was conducted on the gold was in 1974, and it was a partial audit without third-party review. At that particular audit, the gold was not inspected for purity. If this audit reveals that a substantial amount of the gold reported to be in the vaults is not, there will be huge economic, financial, political, and social ramifications. On Feb 20, President Trump told the Republican Governors Association: "All my life, I've heard about Fort Knox. That's where the gold is kept, right? I'm going to actually go. We're going to open the doors. We're going to inspect Fort Knox. We want to make sure that we actually have, you know, 400, tons of gold, or whatever to hell it is. It's a lot of gold. I don't want to open it and the cupboards are bare. If the gold isn't there, we're going to be very upset." RFK

On Feb 13, 2025, Robert F. Kennedy (RFK) was confirmed as Director of Health and Human Services, which is in charge of \$1.7 trillion of the U.S. budget. This is 25% of the total spending of the US government. RFK wrote *The Real Anthony Fauci* about how millions of African children were sacrificed by testing of vaccines under the guidance of Dr. Fauci and Bill Gates. 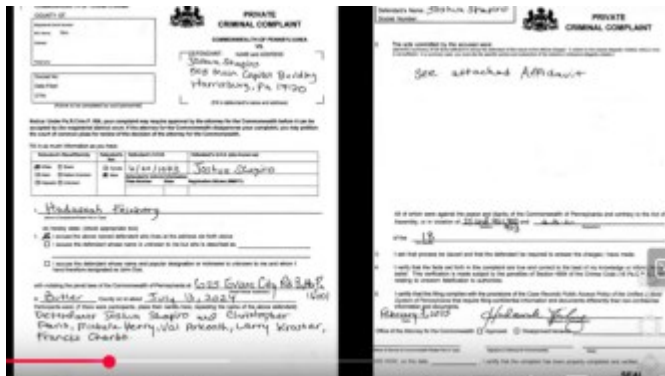
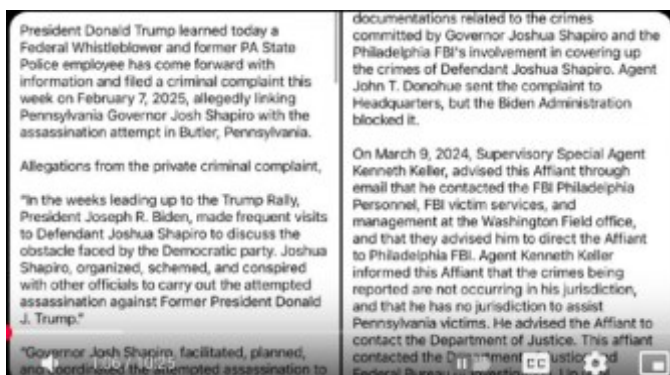

Haddasah Feinberg, a former Pennsylvania State Police employee,



has made serious allegations regarding the attempted assassination of former President Donald Trump in Butler, Pennsylvania, on July 13, 2024

These allegations have led to legal filings, including a RICO lawsuit in the Pennsylvania Commonwealth Court, where Shapiro and Paris are named in connection with alleged corruption and public fraud

It's important to note that these claims are still under investigation, and Butler County District Attorney Richard Goldinger has declined to pursue Feinberg's private criminal complaint, citing ongoing investigations by various government agencies.

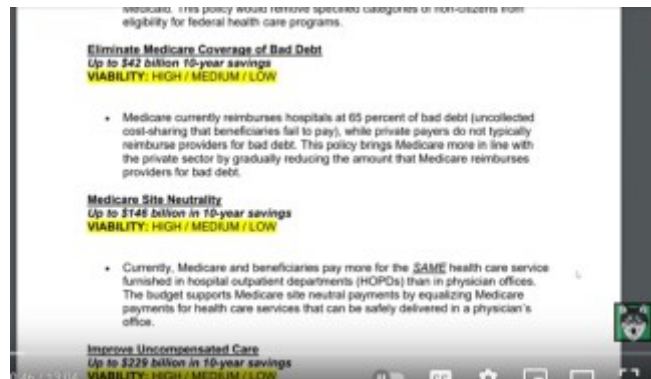

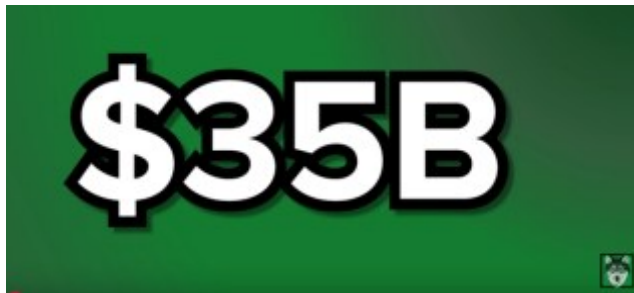
ARE MORE TAXES COMING?

It is a 50 page document released by the House Budget Committee. This contains a list of options that are being considered for the upcoming budget bill, including tax cuts and tax increases. I went through this document and some of these ideas are insane. Before I start complaining, I do need to admit that some of these things are good. For instance, this one.

Limit Federal Health Program Eligibility Based on Citizenship Status
Up to \$35 billion 10-year savings
VIABILITY: HIGH / MEDIUM / LOW

- Currently, many non-citizens who entered the country illegally are eligible for federal health care programs including advance premium tax credits and Medicaid. This policy would remove specified categories of non-citizens from eligibility for federal health care programs.

Limit federal health program eligibility based on citizenship status. This says that the US is currently paying for health care for illegal aliens and if we stop doing that, we could save \$35 billion over the next 10 years.



I did not even know this was going on. Why are we paying to give noncitizens healthcare? Let me see if I understand this. You are taking my tax money and giving it to people who are not even citizens of this country. Can we please stop this?

So there are some things in this document that we should implement immediately. I don't know why we were even doing it in the first place. But then there are some other things that I don't know how they got into this document. For example, they are talking about eliminating the home mortgage interest deduction, which would generate \$1 trillion in savings over 10 years.

Eliminate the Home Mortgage Interest Deduction
About \$1.0 trillion in 10-year savings relative to TCJA extension

- This option would fully repeal the deduction for mortgage interest on primary residences. This is a Tax Foundation score.



This is a massive tax increase for a lot of Americans. When you do your taxes, if you itemize deductions on schedule A, you are able to take a deduction on the interest you pay on your home.

ARE MORE TAXES COMING?

This is good tax policy. We want to encourage people to own property. You can even do remodeling. You could take a home equity line of credit to remodel your kitchen and then take a deduction on the interest. Again, this is good tax policy because we want people to keep their houses in good condition. The mortgage interest deduction is a great thing. I don't know why they're talking about getting rid of it. There is even been talk in the past of changing it from a deduction to a credit which would also be good because even more people could benefit. But that's not what the document says. It says to eliminate the deduction.

Eliminate the Home Mortgage Interest Deduction

- This option would fully repeal the deduction for mortgage interest on primary residences. This is a Tax Foundation score.

They're going to take it away! This is devastating for homeowners. Imagine if you bought a home and took out a 30 year loan.



I'm thinking you were going to get a tax deduction. And halfway through, the government says, just kidding. No more tax cuts for you. And then they take it away. Your taxes skyrocket. You can't even sell your home because no one wants to buy because there is no more tax cuts.

But this is not even the worst example in the document. Here is one that would eliminate the exclusion of interest on state and local bonds for a tax savings of \$250 billion.

Eliminate Exclusion of Interest on State and Local Bonds
\$250 billion in 10-year savings
VIABILITY: HIGH / MEDIUM / LOW

- Interest earned on municipal bonds is currently excluded from taxable income. This option would end the exclusion, making income from municipal bond interest taxable.



When I read this, my head was literally about to explode. What do these people think they're doing? Let me explain how bad this is. When you fill out your 1040 tax forms, you can write in any income you receive from tax exempt state and local bonds.

That means you're not going to be taxed on this income. If they remove this exclusion, that means you're suddenly going to be taxed on all of it. This is going to have a huge impact on people who are retired, even if you don't hold the individual bonds. If you have a pension or an investment fund as part of your 401 K, I am, 99% sure they are holding some of these bonds. That means the cost is going to trickle back down to you. This is going to affect you. I know of people whose entire retirement is nontaxable bonds. Now, I personally would not recommend that investment strategy, but it works for some people. You get your income and you never have to pay any taxes. But now, suddenly it's all taxable. This is insane!

The reason this exemption was created in the first place is that it is good tax policy. You want to exempt state and local bonds because it gives people an incentive to invest in their local communities. This is the money that goes to build local schools, parks and roads.

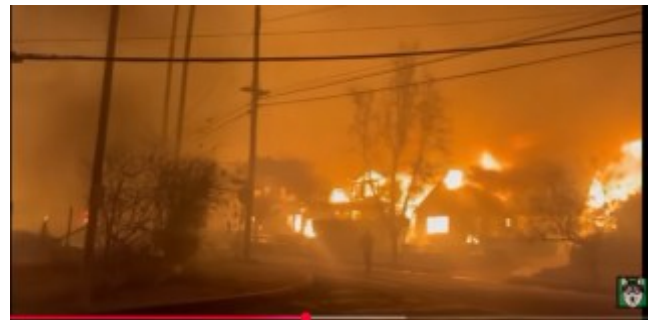
Now some think that getting rid of these bonds will be good because this will mean less government spending. But don't be fooled. That's not what's going on here. All it's going to do is incentivize people to choose federal bonds over state and local bonds. Federal bonds are more attractive because they are backed by the full faith and credit of the US government.



So if you had to choose between purchasing US bonds or bonds backed by, say, the state of California you would choose the federal bonds because California keeps running out of money. But if Cali-

ifornia bonds are tax exempt, it actually makes sense to get state bonds because they would be less risky. The bottom line, this is a huge tax increase for a lot of Americans. It's going to cost the states who are just going to have to raise your property taxes. So you're going to get a federal tax increase and a state tax increase. You are going to get two tax increases. Plus, this will destroy the state's ability to raise money.

Consider this, California just had these huge wildfires.



How are they to raise money to rebuild Los Angeles? They're not going to be able to issue bonds at a good rate. All the investment money will go to federal bonds instead.

And what are federal bonds used for? Do you remember last year when Congress approved \$200 million for a brand new FBI building.



That is what they're using the money for. You are not going to be able to get a local school to educate your kids but the crooked FBI gets a big fancy new building. I am so mad. How dare they raise all of our taxes? How about you disband the crooked FBI and leave our local bonds alone?

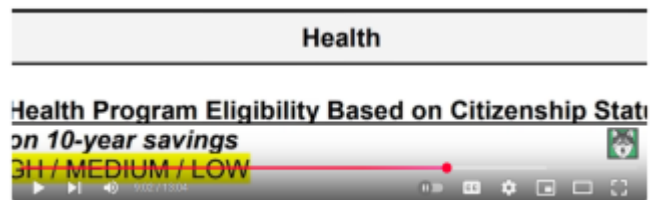
al government. Thank you.”

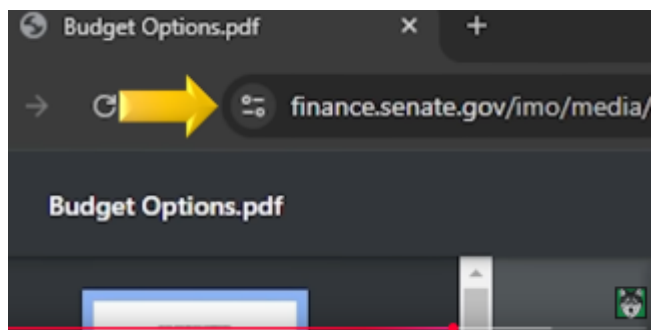

Musk: What is the goal of DOGE? We are to help the president. A significant part of the Presidency is to restore democracy. Let's face it if there's not a good feedback loop from the people to the government, and if you have rule of the bureaucrat, if the bureaucracy is in charge then what meaning does democracy actually have? If the people cannot vote and have their will be decided by their elected representatives in the form of the President and the Senate and the House, then we don't live in a democracy. We live in a bureaucracy. So it's incredibly important that we close that feedback loop. We fix that feedback loop, and that the public's elected representatives, the President of the House and Senate decide what happens, as opposed to a large unelected bureaucracy. This is not to say that there aren't some good people who are in the federal bureaucracy. But you can't have an autonomous federal bureaucracy. You have to have one that

is responsive to the people. That's the whole point of a democracy. And if you ask what do you think of the way things have turned out, we have this unelected fourth unconstitutional branch of government, which is the bureaucracy which has in a lot of ways currently more power than any elected representative. And this is not something that people want and it does not match the will of the people. So we've got to fix it. We've also got to address the \$2 trillion deficit. If we don't do something about this deficit, the country is going bankrupt. It's really astounding that it is considered optional to reduce the federal expenses. Musk: OK, Right. Well, we do find it sort of odd that there are quite a few people in bureaucracy who have essentially a salary of a few \$100,000 but somehow managed to accrue 10s of millions of dollars in net worth while they are in that position, which is what happened to USAID. We're just curious where their gains came from. They're very good at investing in which case maybe we should take their investment advice, perhaps. Just this year, they mysteriously get wealthier. We don't know why. Where does it come from? I think the reality is that they're getting wealthier at taxpayer expense. That's the honest truth of it.

If you look at the Treasury, for example, basic controls that should be in place in any company, such as making sure that any given payment has payment categorization codes. Where there is a comment field that describes the payment and that if a payment is on the do not pay list that you don't actually pay it. None of those things are true currently. So the reason that departments can't pass audits is because the payments don't have a categorization code. It's like just a massive number of blank checks just flying out of the building. So you can't reconcile blank checks. You've got comment fields that are also blank. Don't know why the paper was made and then we've got this truly absurd do not pay list which can take up to a year before an organization gets on the do not pay list. And here we're talking about terrorist organizations, we're talking about known fraudsters, known aspects of waste, known things that do not match any congressional appropriation can take up to a year to get on the list. And even once on the list, the list is not used. It's mind blowing. So what we are talking about here, we're really just talking about adding common sense controls that should be present, that haven't been present. So you say, well, how could such a thing arise? Well, when you understand that that really everything is geared towards complaint minimization then you understand the motivations. So if people receive money, they don't complain obviously. But if people don't receive money, they do complain. And the fraudsters complain the loudest and they are the fastest. So, then when you understand that, then that makes sense. Oh, that's why they approve all the payments at Treasury because if you approve all the payments, you don't get complaints.

But, now we're saying that no, actually we are going to complain. If money is spent badly, if your taxpayer dollars are not spent in a sensible approved manner, then that's not okay. Your tax dollars need to be spent wisely. It's just common sense. It's not draconian or radical. It's really just saying let's look at each of the expenditures and say, is this actually in the best interest of the people? And if it is, it's approved. If it's not, we should think about it. So there's crazy things like just a cursory examination of Social Security, we've got people in there that are 150 years old now. Do you know anyone 150 years old? I don't, OK? They should be able to get a world record. They're missing out. So you know that's a case where I think they're probably dead. That's my guess. Or they should be very famous, one of the two. And then there's a whole bunch of Social Security payments where there's no identifying information. But why is there not identifying information? Obviously we want to make sure that people who deserve to receive Social Security do receive it, and they receive it quickly and accurately.

Also, I know another crazy. So, you know, one of the things we're trying to sort of right size the federal government. So we're saying well, let's see if people can retire with full benefits and everything. And then we're told the most number of people who can possibly retire from the federal government in a month is 10,000. We're like, well, why is that? Well, because all the retirement paperwork is manual on paper. It's manually calculated and written down on a piece of paper. Then it goes down a mine. And like what do you mean a mine? Like, yeah, there's a limestone mine. Where all the retirement people work. And you look at pictures of the mine and we will post the pictures afterwards. And this mine looks like something out of the 50s because it was started in 1955. It looks like a time warp. And the limiting factor is the speed at which the mine shaft elevator can move determines how many people can retire from the federal government. And the elevator breakdowns sometimes and then nobody can retire.

Doesn't that sound crazy? There is like a 1000 people that work on this, so I think if we take those people and say like, you know what, instead of working in a mine shaft and carry manila envelopes to boxes in a mineshaft, you can do practically anything else and you would add to the goods and services of the United States in a more useful way.

If you say how do we increase prosperity as we get people to shift from roles that are lower to negative productivity to high productivity roles and increase the total output of goods and services, which means that there's a higher standard of living available for everyone. That's the actual goal.

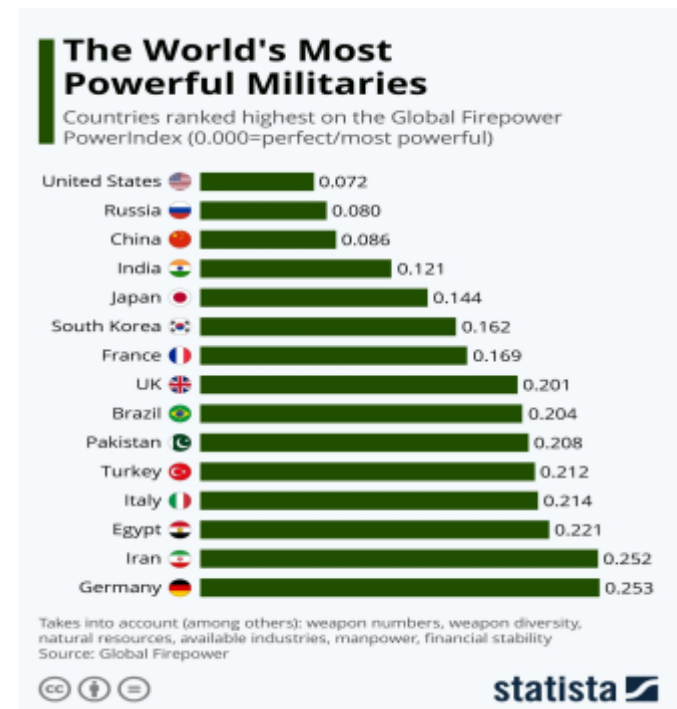

So, we can see Japan has quite a powerful military. But the relationship between the government, which controls the military, and the people themselves is tenuous. The government opposes gay rights and gender equality and generally promotes a Confucian vision of the family. This vision emphasizes respect for elders, submission to the family, and viewing the family as a clan where the institution is more important than the individuals. On the other hand, the government's view of Japan's role in the world is very different from that of the people. While the government seeks greater international influence and a stronger military, the people remain largely isolationist.

The relationship between the emperor, the government, and the people also highlights

significant differences. The imperial household has never had a truly good relationship with the government and has always maintained a more moderate and tolerant stance. The notion of the emperor as a god did not come from the emperor himself. The people love the emperor, but the government does not. In fact, the imperial household often behaves in ways the government dislikes.

Most of the ruling party members belong to Nippon Kaigi, an ultra-conservative organization. It is Japan's largest ultraconservative and ultranationalist non-governmental organization and lobbying group

Founded in 1997, it has around 38,000 to 40,000 members. The organization aims to promote a nationalist interpretation of Japan's history and culture, and it advocates for the revision of Japan's postwar constitution, especially Article 9, which forbids the maintenance of a standing army. Nippon Kaigi also supports patriotic education, official visits to Yasukuni Shrine, and a nationalist view of State Shinto. The group has significant influence in Japanese politics, with many members in the National Diet and several prime ministers being affiliated with it. This is the likely reason Japan has a strong military.

So if Japan were forced into a decision to enter WWII or not, would the government and the people be in sync with the decision? That may be a good question.

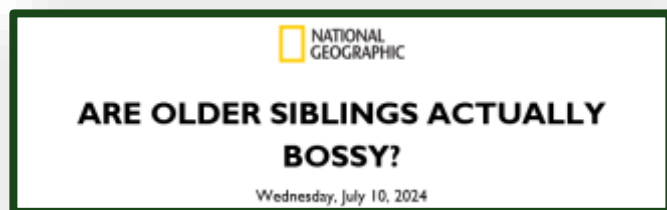


Does Birth Order Determine Personality?

I am the oldest sibling in my family. Some say I exhibit the traits and quirks of an oldest born. I thought I would investigate this and found a study published in a recent edition (July 2024) of the National Geographic and wanted to share it with you. The study is instructive and while I don't agree with some of the findings, maybe you will find it informative and can converse about it at your next party.

Does being the oldest or youngest sibling really shape your personality?

The psychological debate about sibling order has persisted for decades—but it might be time to break up with the popular theory.

Are you a responsible oldest child, an overlooked middle, or a free-wheeling baby? For those who adhere to the theory that birth order influences personality, the answer to that question may hold the key to who you are as a person. At parties, family dinners, and therapy sessions, people can use birth order as a kind of shorthand for personality traits—an only child's selfishness, perhaps, or a middle child's struggle for visibility.

But though your personal experiences may very well indicate that birth order forms the personalities around you, psychologists beg to differ. Here's why it might be time to drop the stereotypes.

Origins of the psychological theory of birth order

The idea that birth order influences a child's personality might be as old as people themselves. After all, various societies have long privileged—or overlooked—people based on where they stand in their family.

In many ancient societies, for example, the arrival of a first child—and thus a parent's transition to the head of a family—often translated to a higher social status. It also gave rise to ceremonies like special baths for first-time mothers in Micronesia and the traditional pidyon haben ceremony in Judaism, during which a first-born son is “redeemed” by paying five silver coins to a priest.

Birth order has also long determined inheritance rights and royal lines of succession, as in the British monarchy which has long demanded a first-born “heir” and one or more “spares” as backups should something happen to the heir.

But the psychological theory of birth order didn't develop until the early 20th century, when psychologist Alfred Adler theorized that birth order influenced not just social status, but a child's development and personality. Known as the father of individual psychology, Adler theorized that an individual's “family constellation” results in predictable personality traits. “The position in the family leaves an indelible stamp upon the individual's life style,” Adler wrote in 1931.

According to Adler, the birth of a sibling deprives oldest children of their parents' undivided attention—and as a result they are neurotic, more prone to conservatism, and inclined to imitate their elders. Second children are competitive attention-grabbers, while youngest children are pampered and lazy. Finally, he theorized that people who grow up without siblings have a “mother

complex” and are in rivalry with their father.

Famous for his international lectures, popular psychology texts, and psychotherapeutic techniques, Adler’s influence still resounds throughout the field of psychology—and as a result, generations of psychologists undertook research that attempted to prove his theory of birth order.

What the research actually says about birth order

Studies conducted since Adler’s time have found associations between birth order and everything from educational attainment to sexuality to middle children’s success in team sports.

Frank Sulloway, one of the theory’s most prominent modern advocates, looked at adults and their careers in the 1990s and 2000s to assess the influence of birth order. He found a tendency for conservative research among famous firstborn scientists, with more radical research, such as the theory of evolution and relativity, more common among famous scientists born later in their family order. He also found differences between military and political strategies among militant firstborns like Maximilien Robespierre and moderate, nonviolent methods among famous middle-borns.

But the studies that most applicable to personality development look at the “big five” personality traits of openness, conscientiousness, extroversion, agreeableness, and neuroticism. And more recent birth order studies throw cold water on the theory that your birth order can shape your personality.

Rodica Damian, an associate professor of psychology at the University of Houston, conducted one of the largest such studies in 2015, using data from a longitudinal study of over 440,000 U.S. high school students. After controlling for socioeconomic status, sex, and age, the study showed that “the association between birth order and personality traits is as close to zero as you can get,” she says.

Another 2015 study underscored Damian’s findings: After analyzing three nationally representative samples from the U.S., Great Britain, and Germany, researchers wrote “we consistently found no birth-order effects on extraversion, emotional stability, agreeableness, conscientiousness, or imagination.”

But both teams of researchers found evidence for one trait that would please firstborn children (and dismay their younger siblings): The studies each showed that firstborns were slightly more likely to have high verbal intelligence.

This doesn’t necessarily mean that firstborns are smarter or learn

more easily, Damian says. More likely it’s because firstborns spend more time around adults in their early childhood—and she points out that in her study, the difference was a matter of a single IQ point.

Overall, the other study team wrote, “we must conclude that birth order does not have a lasting effect on broad personality traits outside of the intellectual domain.”

What really makes a personality?

As a scientist, Damian is cautious about claiming that any theory has been “disproven.” However, she says that modern research essentially debunks the theory that birth order affects personality—which she calls a “zombie theory” because it just won’t die. So why does the idea still enchant the public—and why do researchers continue to plumb the question?

“Everybody has an opinion on it because everybody has a birth order, even only children,” says Damian. And part of the reason we just can’t quit birth order psychology may have to do with our own experiences that will always appear to support it. Older children will always seem to be more responsible and sophisticated than their younger siblings because they are more developmentally mature.

Even though you see this and it’s true, you don’t have a magic lens to go back in time and observe the children at the [exact] same age,” Damian explains. It’s a “perfect confound,” she and her colleagues write—and it’s “one circumstance where personal experience will be wrong and the truth can only be discovered through good scientific reasoning and investigation.”

In truth, the science of personality development is anything but settled. Modern research using twin studies suggests that personality formation is about 40 percent due to genetics. The rest may be a matter of a complex combination of environment and cultural practices that help shape the disposition with which we’re born.

Though researchers can measure the “big five” personality traits, it’s harder to quantify the subjective experiences that shape our everyday lives and, perhaps, our personalities. Damian is currently studying the possible effects of people’s life narratives—the stories they tell themselves about their own experiences—on the people they become. But for much of the public, teasing out the complex web of nature and nurture is far less fun than teasing out their siblings.

In 2023, the Army came up 10,000 soldiers short of its goal of bringing in 65,000 new active-duty troops. In 2022, it missed a goal of 60,000 soldiers by 15,000. Those shortfalls were consistent with the decline in recruiting among men. In 2024, the service reduced its goal -- seeking 55,000 new recruits.

The demographic data traces the military's recruiting struggles with the decline spanning the leadership of presidents from both major parties with vastly different public stances on military culture.

Critics have argued that the problem is tied to changes in military policy, including nonspecific claims that the military has become "woke." But experts described broader issues with men becoming less engaged in American society and less likely to enroll and graduate from college, more likely to die by suicide or drug overdose, and slowly disappearing from the general workforce.

The sharp drop in the mid-2010s of men's participation in the workforce, education and military service is part of what some experts call a national "crisis of masculinity" with complex causes.

"[This] goes way beyond military recruitment," Ronald Levant, professor of psychology at the University of Akron and former president of the American Psychological Association, told Military.com. "It really has to do with social change. I think there is a motivational syndrome that seems to permeate a lot of young men today. They're just not motivated to do very much."

Black Pigeon on YouTube has other reasons why men worldwide are not stepping up to defend their country.

We should note this report came out prior to President Trump's executive orders to revamp the Department of Defense. With these

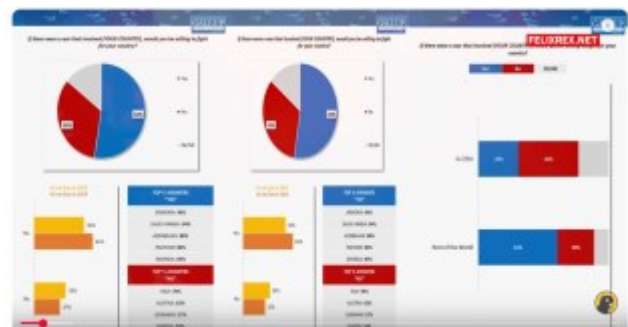
changes, the US military may witness a resurgence in recruitment and morale. Only time will tell.

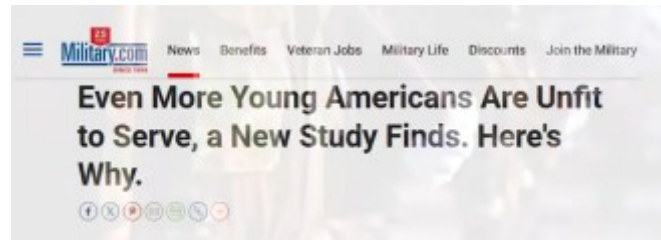
In the United States, the army is reducing its ranks by thousands due to chronic recruiting shortfalls.

Pentagon studies have found that around 77% of young Americans

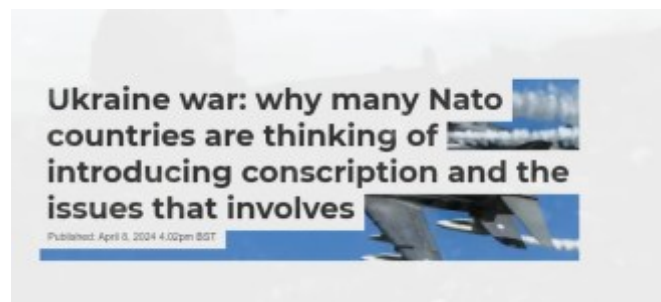
would not currently qualify for military service due to being overweight, using drugs or having other physical or mental health issues.

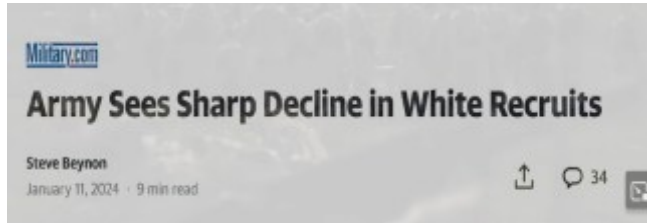

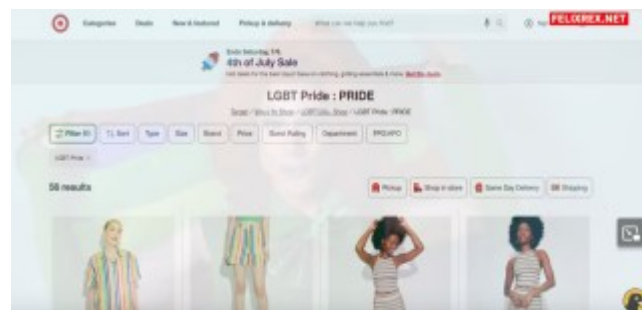

And I agree. I don't think there is a single modern western country worthy of having its men fight and die for it as there's nothing worth





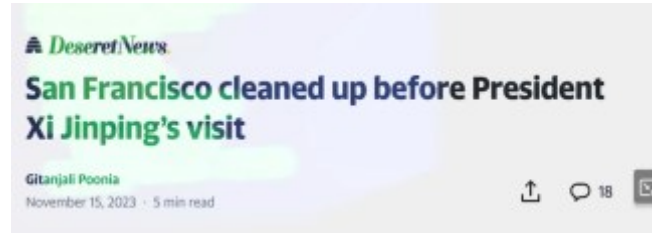

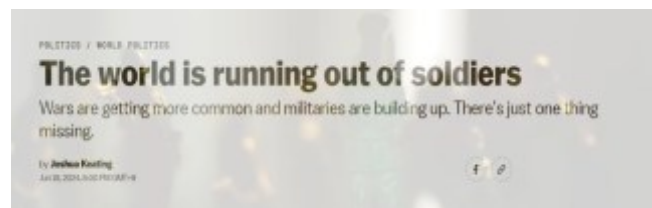

Why Some Veterans Don't Want to Talk About the War



A few associates of mine recently established a digital media company that has been tasked by the Library of Congress to record for its annals the stories of Asian military veterans of Vietnam.

In the course of their work recording the veteran stories, all too often the media company principals discovered that some Vietnam veterans were quite reluctant or in some cases even adamant not to be interviewed about their experiences in the war.

Why does this happen?

We all know that when American soldiers returned home from World War II in 1945, they were greeted as heroes in the United States. This includes the Japanese American soldiers of the 442nd RCT, 100th Battalion and the MIS. Cities and towns across the country held parades to honor these returning veterans and recognized the sacrifices they had made. But the homecoming was very different for most Vietnam veterans. There were no victory parades or welcome-home rallies. Instead, most Vietnam veterans returned to a

society that did not seem to care about them, or that seemed to view them with distrust and anger.

Arnold R. Isaacs wrote in *Vietnam Shadows: The War, Its Ghosts, and Its Legacy*. "Men who fought in World War II or Korea might be just as haunted by what they had personally seen and done in combat. But they did not come home, as the Vietnam vets did, to a country torn and full of doubt about why those wars were fought and whether they had been worthwhile. Nor did they return as symbols of a great national failure."

Many young men who fought in Vietnam had a great deal of difficulty readjusting to life in the United States. Some struggled to overcome physical injuries, emotional problems, or drug addictions from their time in Vietnam. Others had trouble feeling accepted by their friends and families. Some returning soldiers blamed their situation on the antiwar movement and developed a deep resentment toward antiwar protesters. But many other veterans began to question the war and their own actions in it.

Some people who opposed American involvement in the Vietnam War treated U.S. soldiers and veterans poorly. They tended to blame American troops for the tragic situation in Vietnam, instead of blaming the government leaders who had sent them there. Some protesters simply did not make a clear distinction between the war and those who fought it, and they regarded American soldiers as ready and willing killers or ignorant dupes.

But for the most part, rather than being greeted with anger and hostility, most Vietnam veterans received very little reaction when they returned home. I know in my case; people seemed uncomfortable when they learned I served in Vietnam and they did not appear interested in hearing about my wartime experiences. In his book *Working Class War*, Christian Appy explains "Society as a whole was certainly unable and unwilling to receive these men with the support and understanding they needed. The most common experiences of rejection were not explicit acts of hostility but quieter, sometimes more devastating forms of withdrawal, suspicion, and indifference."

So confronted with reactions of indifference, fear, or anger, some veterans (including me) kept their wartime experiences to themselves. They refused to discuss Vietnam with anyone but other veterans, because no one else seemed to understand or care. Veteran Jamie Bryant mentioned in *Vietnam Shadows* "There has really never been anyone who has asked me: 'What happened to you over there? What was it like?' It's like having a whole year of your life that didn't exist. When you first get back, you don't think about it much. Then you begin to wonder why no one asks the questions. Then you begin to feel like maybe it isn't something you should talk about."

When I returned from Vietnam I had quite a difficult time readjusting to the life I once knew. I suffered countless nightmares seeing a formless grey blob always chasing me through the jungle. Even years after I was married, I continued to struggle with the pangs of PTSD. It was only after many years of therapy and the healing balm

of time that I was able to regain some normalcy in my life. But I still never really opened up about my experiences to loved ones including my wife and children. When I was interviewed by my associates mentioned above, I found it to be a great cathartic and liberating experience that I would recommend to other veterans who have the opportunity. But frankly, I still have not mentioned undergoing this interview to my own wife and children.

We know by the 1980s, Americans began to change their views of Vietnam veterans. They began to see that even if the war was wrong, most of the men who fought it were just ordinary guys doing their jobs. Some people started to feel sympathy and even gratitude toward the veterans. Soldiers who had served in Vietnam finally began receiving recognition and marching in holiday parades across the country. In 1985, Newsweek reported that "America's Vietnam veterans, once viewed with a mixture of indifference and outright hostility by their countrymen, are now widely regarded as national heroes." In our own Japanese American Nisei Week Parade held annually in Los Angeles, the Japanese American veterans of all the wars are now hailed and welcomed with shouts of "Thank You for your Service" and "Welcome Home". This is a far cry from what we veterans experienced in the 1970's.

But why do Vietnam veterans including myself have a difficult time talking about our war experiences with our close family members?

To help answer this question, I found a recent report by a Doctor of Psychology Debra Nofziger, who is a deployment behavioral health psychologist with the Center for Deployment Psychology at the Uniformed Services University of the Health Sciences. Dr. Nofziger is currently located at the Brooke Army Medical Center in San Antonio, TX.

We note that Dr. Nafziger's work analyzed the reasons white veterans did not talk about their war experiences with their close families. And not being Asian, Dr. Nofzigler, would not likely be particularly sensitive to the problems of shame that could affect Japanese American veterans in a war. However, this is a subject of sufficient depth that needs to be covered in a separate article.

In any case, in her report Dr. Nofziger cites as the first reason veterans do not to want to talk about their experiences in Vietnam is because of their fear of breaching Operations Security Measures.

As a Combined Action Platoon leader in Vietnam, I was required to work with certain US intelligence agencies outside of the base. Accordingly, I was required to follow certain Operational Security Measures that resulted in a continuing nagging concern on my part for breaching any of them. This made me somewhat gun shy to talk with anyone about what I was doing in the field, and I believe this diffidence to discuss my experiences in Vietnam with others carried on in my civilian life.

For the reading consideration of my fellow Vietnam veterans as well

as other subscribers, I present Dr. Nofziger's article.

Staff Perspective: Sharing Combat Experiences – Why Veterans Struggle Opening Up to Loved Ones

If you have ever worked with a combat Veteran, at some point you have heard frustration from both the Veteran and family members about their communication specific to details about combat experiences. "Why doesn't he tell me about what happened? He shuts me out! Doesn't he trust me enough to be open about what he is going through?" Or, from the opposite side, "Don't they get that they shouldn't push me?! I don't want to go there with them! I feel bad shutting them out, but what else can I do when even I can't handle the details??" I leave it to you to figure out which of the above is which party, but I'll bet you can easily guess. I was recently listening to a patient of mine with this common problem, and he put it very well – "I should tell my wife everything. But I don't.... I can't. It is too much to pile on her, and it would hurt her. So I don't. I push her away instead, block her questions out so my pain won't be her pain." Listening to him, and all the others with similar statements, always seems to take me back to the first time I explained this issue with a patient and his family. Recently back from combat myself, I found that I identified with this concern all too clearly. Have you ever had a time when you wished you were recording what was coming out of your mouth because it was spot on and you knew you will never be able to repeat it like that again? That is what it was like for me. But it was also an "Aha" moment in my world, both professionally and personally in terms of my combat experience-sharing with loved ones. Ever since then, I strive to help couples understand limited sharing and to be more okay with NOT sharing all of the details that loved ones think they want to know (but really don't). The following are my list of why Veterans may not share.

The first reason is Operational Security or OPSEC. This reason falls on the Veteran to make adaptations. While in combat, OPSEC is critical – you do not share information with people who do not have a need to know. If you do, you can literally be giving information to the enemy, albeit accidentally. I've seen that happen. So being tight lipped, especially over the phone and in written communications, becomes a habit. This habit carries over once the Veteran returns home. The problem is the Veteran doesn't recognize that in the home environment, the "need to know" circle broadens to include close loved ones. They need to have enough information to have at

least a rudimentary understanding of the difficulties the Veteran is going through. If your bed partner keeps waking up screaming, having a general idea of the traumatic nightmare experience can be important to increase support and patience. I'm not saying loved ones need ALL the details, but they do need some of them.

The next reason, which I actually find every time this is discussed, involves the Veterans wanting to protect their loved ones. Combat memories can be painful, and they want to protect their family from experiencing pain. It is because the Veteran loves their family that they hold back information. Not only are they protecting loved ones from emotional pain, but also from future anxiety in the event of another deployment. There are things my mother will never know about my combat experiences. When I was still in uniform, I wouldn't dream of telling her because if I deployed again, her fear for me would increase exponentially. Now? I still wouldn't dream of it because, though it was over a decade ago, she would still have nightmares about her daughter's experiences. And I was not a direct ground combat soldier. Imagine the horrors that actual ground troops are protecting their loved ones from!

Veterans also don't share combat details because they fear their family's reaction, specifically rejection or pity. "If they knew what I had to do, what I am capable of, they will think I'm a monster." Families often share frustration that Veterans are more willing to talk to each other than them. But, coming from this angle, it makes sense. Combat Veterans share similar experiences and understanding about how war changes you, and what you learn about the dark side of yourself. It is hard to accept this darkness and it is something Veterans struggle with. If they can't accept it in themselves, imagine how hard it would be to believe that loved ones would accept it. When explaining this to couples, I encourage small steps in information sharing, and for the loved ones to be understanding that combat can bring out the dark side of people. Everyone is capable of doing extreme things under extreme circumstances – it does not define the totality of the person.

A less tangible reason that Veterans don't share war experiences with people at home has to do with anti-contamination – what happened in war is "unclean" and needs to be left there. Home is your castle, your safe zone. Why would you want to tarnish home by bringing war in to it? It is interesting how strongly Veterans nod when I bring this up. They work to compartmentalize "home" from "war" as a way to cope. When they look at their families, they don't want to be reminded of combat. They sense that if they share their stories, memories and war invade their home and contaminate it.

A last thing I talk to with families about why Veterans don't share involves their fear of facing it themselves. This goes to the concept of avoidance. They are working hard to keep the memories away (especially if they have ended up in a behavioral health office). If they go there, they fear they will be flooded. If they start to share information, where do they stop? Will they be able to stop? Or will it just make their memories and emotions that much more difficult to cope with?

Overall, with all of the above reasons I encourage the couples to meet in the middle, with the Veteran sharing at least some details about their difficult experiences and family understanding that they don't need the minutia. Through this discussion, I find that loved ones can appreciate why some information is held back – it is out of love and concern for them. Even when I don't see a family member, I often share the above with Veterans and encourage them to talk to their families about their concerns with sharing information. Loved ones are just looking to help, after all. They aren't trying to make things worse by asking for or receiving information. But totally shutting them out from all information is also not helpful. There has to be an agreed balance, where families have enough information to understand their Veteran better, and Veterans feel they are supported without feeling they have caused pain or other adverse reactions. And, as always, I encourage couples and families to seek out their own individual or couples interventions if there are continued difficulties.

While the above reasons for Veterans holding back information are true to my experiences, you may certainly disagree, have others, or have better ways to explain the above. I look forward to more observations and fine-tuning my own understanding so I can continue to better support Service members and their loved ones.

We see more violent events, more robberies at the local and regional levels. Just in my immediate neighborhood, the news reported an increase in burglaries of houses during the dinner hours. These things are becoming very visible now. What happens in the next couple of months will show us the trend for the future.



The economists I follow paint a rather dark picture for the immediate future. They say that even though the Trump administration is doing what is absolutely necessary for our society and culture to

survive and prosper, it is going to be a painful process between now and when we get to that point where what we are putting in, finally pays off. The analogy that comes to mind is an individual who is working out, has got to put in the burn to gain the muscle. You must go to the gym and you have to exercise, walk and run. You will have to work harder to have the same level of earnings.



For the government, they have to recover the sinking ship that was allowed to operate for the last 30 years. This sinking ship pushed us as a country into very dangerous territory. We are really at risk

of total systemic collapse. You can see from the trillion dollar trillion-plus debt just in the entitlement program, there is tremendous waste and fraud that has been brought out into the open by Elon Musk and DOGE. You can see the amount of corruption in politics has pushed us to near total systemic collapse. There is little trust in government, there is little trust in private corporations. Everything is viewed as an entity with an agenda and a narrative, and the people, even the ones who are caught up in the left, right political paradigm, the Democrats versus the Republicans, even those people, even though they're toeing the line, they don't believe that there will be any change, any sort of positive outcome in the future.

So, what are the next six months going to look like? For me I see more inflation in the

short term. We are going to see even more information come out about government waste, fraud and corruption. You're going to see the people who have the most to lose inside politics speaking out the hardest against the system. They are going to be really against Donald Trump. They are going to be pushing very heavily against Elon Musk. They're going to push hard and heavy against RFK Junior because his position has the chance to upset the status quo of people like Senator Elizabeth Warren who said the chemical pharmaceutical industries may face bankruptcy. Sixty percent of the TV ads are from pharmaceutical companies. These ads taut their product may make 10 things worse, but it might clear up that itchy patch on your elbow, or hey, you've got ulcerative colitis, and instead of diet and exercise like RFK Junior is trying to tell you, here is a medication that might have 60 side effects, ruin your liver and you might die of an early stroke, but it might treat your problem. But that is the agenda that the politicians and bureaucrats have been allowed to pursue.



And then they wrote it into law that no matter what these bad side effects were, no matter what happened, you do not have a chance to sue them. The only real justice

that we have allowed to take place in this country is that if somebody wrongs you, you can bring them to court for some punitive damage. That was true in history throughout the ages. If you wrong somebody there had to be some sort of recourse, something to make it right again. Well, it just so happens that our world today operates on the US Dollar. In other cultures, they might bring you a goat or they might be able to make amends by giving you some land for you and your family. You recall the Kings and Queens in history who donated a bit of land to a family who was wronged and told them OK, here you go, you can become the Lord of your own little place. But don't forget you're still paying your taxes. And that's how they dealt with wrongs. There was some means to make amends for a wrongdoing.



We haven't had that in our culture, so all the politicians who have been on the take,

who have been corrupt in the shadows, are very afraid of what this new Trump administration and this wiping of the slate will mean because some of them, Senator Warren in particular has a lot to be concerned about. Warren makes \$200,000 a year on salaries. And that's a decent amount of money. But her net worth is in the 10s of millions of dollars, and that's what's on paper. That's not what has been pushed to family members or through escrow accounts, or trusts that have been set up, or corporations that have spent the money. That's just Warren's net worth on paper.

That is something that can be unearthed . It could be 50 or 60 or a \$100 million. Who knows. And that's how corruption is. You just don't know what will happen. And so many of the politicians are corrupt.



So we are going to have a worsening condition. In the next

six months, people are going to realize that we have been taken hook, line, and sinker, and have been screwed all the way down. The politicians and bureaucrats have been playing on our future. Maybe this might turn around in a reasonable amount of time. But in the meantime, what President Trump has to do, and the economists are seemingly backing him up on this, he will have to institute an American first agenda that will make our prices higher for the short term. That is unnerving but the tariffs will have to run their course before the foreign powers come to understand that they will need to cooperate with America if they hope to survive themselves.

Now, the countries are saying it's too risky out there and they want their gold back. They say we can see World War III. We can see a complete collapse of the American Empire under Trump.



The American people will need to bite the bullet for a while for America to recover and again become the great power that President Trump has envisioned. Many people are upset right now

about what is going on. Many feel this Trump administration is going to be damning to the US government and believe this will be the apocalypse, the great end all be all and the start of the unraveling of American culture and its way of life.

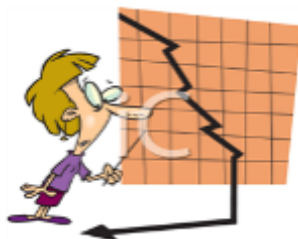
