April 1, 2025, Senator Cory Booker delivered a historic speech on the Senate floor, breaking the record for the longest known Senate speech in history. Starting at 7 p.m. on Monday, April 1, 2025, Booker spoke for over 24 hours and 18 minutes, surpassing the previous record set by Strom Thurmond in 1957. His speech was a protest against President Donald

Trump's policies during his second term. Booker remained standing throughout the marathon speech, reading letters from constituents, quoting poetry, and discussing various issues such as healthcare, education, and national security. Despite its length, the speech was not considered a filibuster as it did not aim to block specific legislation. It was a powerful display of stamina and determination to highlight what he described as a "crisis" in the nation



On April 9, 2025, the stock market made its best single day performance in 24 years. It experienced a remarkable rebound, driven by a temporary 90 day pause on global tariffs announced by President Donald Trump. This decision excluded China, where tariffs were increased to 125%. The announcement

came after a period of significant market volatility, during which U.S. stocks had dropped over 12% in just four days. The S&P 500 surged by 9.5%, the Dow Jones Industrial Average climbed 7.9%, and the Nasdaq soared 12.2%. This rebound was fueled by investor optimism and a sense of relief, as the tariff pause provided breathing room for potential negotiations. It was a dramatic day for the markets, showcasing how quickly sentiment can shift in response to policy changes.



April 3 and 4, 2025, marked the largest two-day downturn in stock market history. Over these two days, companies on the U.S. stock market lost approximately \$6.6 trillion in value. This dramatic drop was triggered by the announcement of sweeping global tariffs by President

Trump, which exceeded market expectations. The tariffs, aimed at nearly all U.S. trading partners, sparked fears of a trade war and potential global recession. Major stock indices suffered significant losses: the S&P 500 fell by 5.97%, the Dow Jones Industrial Average dropped nearly 1,700 points (about 4%), and the Nasdaq Composite tumbled 6%. These declines were the worst since the early days of the COVID-19 pandemic. The technology sector and companies heavily reliant on global trade were hit particularly hard, with some major players seeing double-digit percentage losses. This downturn has raised concerns about the broader economic impact and the potential for prolonged market instability. We will report on later downturns in the market as they occur.



April 14, 2025, marked a historic milestone in space exploration. Six women embarked on a journey to the edge of

space aboard Blue Origin's New Shepard rocket. This all-female crew included pop star Katy Perry, journalist Gayle King, civil rights activist Amanda Nguyen, former NASA rocket scientist Aisha Bowe, filmmaker Kerianne Flynn, and Lauren Sánchez, who is Jeff Bezos' fiancée. The flight lasted approximately 11 minutes, during which the crew crossed the Kármán line, the internationally recognized boundary of space, experiencing moments of weightlessness and breathtaking views of Earth. This mission, known as NS-31, is the first all-female spaceflight since 1963. After the conclusion of the flight, It was noted there was considerable criticism by the public on social media and YouTube programs about the lighthearted and trivial antics of the six ladies during their 4 minutes in weightless space. According to AI, the 11-minute Blue Origin flight was merely a high-tech amusement ride.



On April 7, the U.S. Supreme Court ruled in favor of the Trump administration, allowing the resumption of deportations under the Alien Enemies Act. This decision specifically pertains to alleged members of the Venezuelan gang Tren de Aragua. The court's 5-4 ruling lifted a previous

restraining order that had blocked these deportations. However, the

April 14, 2025, United States **Hospital Threat Assessment** bulletin was released by CommandEleven, an intelligence unit based in Pakistan. The report was reviewed by various intelligence officers and approved for credibility. The report warns that hospitals and Tier 1 trauma centers are being

April 15, 2025, Harvard stands to lose \$2.2 billion in federal funding, facing one of the gravest confrontations in its history as it rejects the Trump administration's demands. The administration's demands included ending diversity, equity, and inclusion (DEI) pro-

grams, adopting merit-based admissions, and cooperating with immigration authorities. Harvard's president, Alan Garber, argued that these demands infringe on the university's independence and constitutional rights. He emphasized that no government should dictate what private universities can teach or whom they can admit and hire. The administration justified its actions by citing concerns over antisemitism on campus, claiming that Harvard failed to protect Jewish students. However, Garber stated that while Harvard is committed to fighting antisemitism, the government's approach is not cooperative or constructive. This funding freeze could significantly impact Harvard's research initiatives, which rely heavily on federal grants. The case has sparked debates about the balance between government oversight and academic freedom. Some say Harvard can afford it. Harvard is the world's wealthiest university, but its \$53 billion endowment isn't the bottomless piggy bank it seems. About 70% of the endowment funds are earmarked for specific programs by donors and cannot legally be used for unrelated purposes. But 20% is unrestricted and can plug budget holes. And if the administration succeeds in yanking Harvard's tax-exemption—which would likely entail a lengthy legal fight—the school could owe taxes on that endowment and its large real estate holdings.



In April 2025, a split in the House White position on Iran became evident. President Trump has vowed to prevent Iran from getting a nuclear weapon — but inside his Administration there is a split: The president's national security

team has a dialogue faction and an attack faction in dealing with Iran's nuclear aspirations. Witkoff, Vice President JD Vance and Defense Secretary Pete Hegseth are pushing for diplomacy and compromise; Secretary of State Marco Rubio and National Security Advisor Mike Waltz express deep skepticism over Iran's intentions and seek a more hard-line approach, believing Iran is now very weak. President Trump himself seems split down the middle—on one hand pushing hard for an ill-fated deal and even showing himself willing to frustrate Israeli Prime Minister Benjamin Netanyahu over it—and on the other making continual threats and dispatching aircraft carriers and B-2 bombers to the region to prepare for conflict. Will Trump's peace plans fly? Interestingly, Bible scholars believe based on the prophecies in the Bible that ultimately, Iran will survive America's pressure and the U.S. will lose its global standing both as a peacemaker and a policeman. And according to these same Bible scholars, that's not the only Bible prophecy Trump

appears to be accelerating: Europe must pick sides—China or America: President Trump is calling on Europe to sever ties with China before he will make a deal over trade tariffs. Trump is essentially asking European nations to choose between having Chinese raw materials needed to make things or having a US market to sell things to. The Trump administration seems intent on driving Europe into the arms of Asia. And according to Bible prophecy, ultimately, that is just what is supposed to happen.

On April 23, 2025, California officially became the world's fourthlargest economy as announced by Governor Gavin Newsom. This milestone was based on data from the International Monetary Fund and the U.S. Bureau of Economic Analysis, showing California's nominal GDP

reaching \$4.1 trillion, surpassing Japan's \$4.02 trillion. An impressive achievement for the Golden State.



On April 25, 2025, surveys by CBS, ABC, NBC, CNN and the New York Times showed Donald Trump's 41% approval rating is the lowest for any newly elected president at 100 days since at least Dwight Eisenhower. Trump's approval on handling economic issues has dropped no-

tably, with a current rating of 39%, reflecting concerns over his tariff plan's impact on the stock market and prices. A new NBC News Stay Tuned Poll indicates that 55% of Americans disapprove of Trump's job performance. Trump's handling of immigration remains controversial, with 49% of Americans approving, but 51% disapproving of his management of border security.



On April 26, 2025, The Atlantic featured an article The Worst Job in America. It comes with a \$5 million salary, almost unlimited travel, and a complimentary mansion in New York City. Yet no one wants to do it. It makes for a most tempting "Help Wanted" ad: Earn \$5 million a year to

lead one of the nation's most powerful and prestigious institutions. Enjoy fancy dinners, almost unlimited travel, and a complimentary mansion in Upper Manhattan. This is an incomplete list of the perks that the president of Columbia University receives. And yet no one

seems to want the job. In late March, Katrina Armstrong, Columbia's interim president, resigned after an unhappy seven-month tenure, one marked by a never-ending dispute about campus anti-Semitism, and by President Donald Trump's war on Columbia's funding and independence. The school is now on its fourth president in only three years, and its latest leader isn't even an academic. Columbia's difficulty in appointing even an acting president suggests that it may be, at least for the moment, nearly unmanageable. But it is not the only elite university in trouble. Three of the other seven Ivy League universities are led by presidents who began as interim appointments. Across the country, the average length of college presidents' tenure has fallen to less than six years. With declining trust in higher education, campuses fractured over the Israel-Hamas conflict, and a White House eager to wage populist war on elites (a White House run, incidentally, by Trump, a University of Pennsylvania graduate, and Yale Law alumnus J. D. Vance), the job of elite college president, formerly considered difficult but prestigious, has become, on many campuses, impossible and thankless. Presidents are charged with leading an inflexible organization made up of autonomous and competing constituencies through a period that requires immediate change. But they can't do anything without angering either parents, students, professors, donors, administrators, or Trump. Any false step might cost them their position. Being president of an elite university might once have been the greatest job in America. Now it is the greatest worst job.



On April 28, 2025, Spain and Portugal experienced a massive power outage that caused widespread disruptions affecting millions of people across the Iberian

Peninsula. The power failure impacted major cities like Madrid, Barcelona, and Lisbon, as well as parts of France. It disrupted public transport, grounded flights, and caused chaos at airports and train stations. Officials attributed the outage to a rare phenomenon called "induced atmospheric vibration," caused by extreme temperature variations affecting high-voltage power lines. This happened 10 days after Spain announced its grid was now completely powered by renewable energy sources. By early April 29, power was gradually being restored, with over 92% of energy demand met in Spain. But some knowledgeable observers are asking was this a Beta test and a harbinger of things to come.

#### **Humans Make Technological Leaps to Eliminate Themselves**

With this dystopian warning in mind, we've been noting the rise in military combat vehicles designed to operate without humans.

In Forbes magazine's December 2024 issue, they ask the question, "Will AI Test Human Control In 2025?"

According to the article, the answer is yes: "AI is no longer just a tool – it has evolved into a force that increasingly challenges human oversight. Systems are beginning to exhibit behaviors that defy expectations, echoing warnings we once dismissed as science fiction or predictions of the Singularity."

With this dystopian warning in mind, we've been noting the rise in military combat vehicles designed to operate without humans.

It was scary enough when the military debuted its first armed drone in 1995. The MQ-1 Predator UAV (unmanned aerial vehicle) carried two Hellfire missiles, lethal enough to earn the nickname "hunterkiller".

But it was still a drone, which meant there was a human behind nearly every move it made. Without a human working the controls, the best the MQ-1 could do on its own was navigate between two preprogrammed points.

Of course, the military wasn't satisfied with that.

The MQ-9A drone that followed was a huge upgrade, including in size. It has a 66-foot wingspan and doubles the maximum speed of the MO-1, able to fly at over 300 miles an hour.

But most important to our growing existential dread, the MQ-9A boasts 3,800 pounds of weapons, adding laser-guided bombs, jointdirect attack munitions (smart bombs), and sidewinder air-to-air missiles to its allocation of Hellfires.

They called this drone "the Reaper", in case we weren't sufficiently frightened.

As you might predict, the latest drone in the U.S. military arsenal doubled the speed and amount of weaponry once again. The MQ-20 Avenger carries up to 6,500 pounds of smart missiles and guided bombs, and can get them anywhere in the world at nearly 500 miles an hour.

And there is a new feature that got our attention: artificial intelligence has been added to assist with target tracking. AI has a foot in the door. Still, this is a human-controlled drone, and the MQ-20 remains in testing.

But suddenly "human-controlled" is no longer a desired feature.

Recently, we wrote about the launch of the U.S. Navy's first uncrewed battleship. This is a major escalation in unmanned military power. The LUSV Defiant is a completely autonomous warship, operating without any human crew.

Incredibly, it was built without any place for a human to even stand. And it's beyond the testing phase – it was just put to sea.

Of course, the game-changing military vehicle is the fighter jet.

It's the F-15 and F-16 that dominated skies in the Gulf War, and the war in Kosovo in 1999. These same fighter jets delivered swift victory in the 2003 Iraq war. The new F/A-18 Super Hornet joined the arsenal of fighter jets that quickly established air dominance and cleared the way for an easy victory and the fall of Baghdad.

The idea of a fighter jet that was uncrewed has long been a dream of major military powers. There's an obvious reason that isn't so nefarious: anytime a human life can be spared the risk of combat, that's a good thing.

But a future where these dominating military assets could be entirely controlled by AI invites trouble, once AI reaches that magic Singularity, where its models decide the human instructions may not be the orders they follow.

And that future has just arrived.

The Air Force's Collaborative Combat Aircraft program just announced the world's first autonomous combat planes. The YFQ-42A and YFQ-44A are going into production, and the Pentagon hopes to make as many as they can.

Their plan is to offset China's numerical advantages with whole squadrons of unmanned fighter jets. Both the 42A and 44A are half the size of an F-16, but retain all the performance ability.

According to the Air Force, "We are telling the world we are leaning into a new chapter of aerial warfare."

And artificial intelligence is being incorporated into these unmanned combat aerial vehicles to "enhance the performance of the fighter fleet".

These new technological marvels have the potential to save human lives, flying into active combat so we don't have to. But every step humans take in arming artificial intelligence also prepares these large language models for the day they realize they don't need us.

#### **Innovation Assassination: When Inventors** Mysteriously Disappear

What happens when a new process, a new invention threatens the market share of a corporation? What happens when a revolution in technology can cause devolution in an established industry, in its profits, its power on the world stage?

There was a huge American corporation that once had as its motto, 'Progress is Our Most Important Product.'

Nice phrase, but is it always true when it comes to the commercial jungle of mega corporate interests?

Does business really favor progress, or is it only when progress promotes profits is innovation celebrated?

What happens when a new process, a new invention threatens the market share of a corporation? What happens when a revolution in technology can cause devolution in an established industry, in its profits, its power on the world stage?

Sometimes, the inventor of such game changing technology doesn't get a market deal he gets an all-expense paid permanent stay in a mausoleum.

The disappearance of an inventor of innovative products and procedures isn't an isolated incident. There are multiple examples, and we'll explore a few of them.

The reader may have noticed that the oil industry is rather large. The providers of electrical energy are large corporations. When that market is threatened — even by a potential, and unpatented process isn't too much of a stretch to imagine the inventor of that process may have his neck stretched.

#### Submitted for your perusal — Stanley Meyer.

Meyer claimed he had invented an automobile engine that could run on water, and water was both plentiful, and not controlled by major corporations. It was cheap, it was clean, and there was no way in Texas' oil filled acres that the major multinational oil companies would allow that kind of technological advance to happen.

It was possible Meyer was correct; it was possible he wasn't.

However, what is certain is that Meyer was at his own 'Last Supper' when after downing a cranberry juice at lunch, Meyer was down for the count — dead at fifty-seven years old.

He immediately reacted to the cranberry juice, ran into the parking lot of the restaurant that was to be his final destination, and declared, 'They poisoned me.'

Meyers claimed that he was both subject to threats and offered bribes by oil companies that wanted his ideas to disappear.[1]

Instead, it's possible, though not proven, that somebody made Meyers disappear.

Let's look at another case of an inventor who might have been removed from the playing field of mega corporate profits.

Tom Ogle, once again, an inventor that threatened the multinational mob of energy providers. Ogle invented 'a vaporized fuel system which allowed a car to travel over 200 miles on two gallons of gas.'

That obviously, wouldn't have pleased the oil companies. Unsurprisingly, Ogle's technological advances never came to fruition, because Ogle was found dead.

Ogle had used the technology on his own 1972 Thunderbird. He was able to get more than one hundred miles per gallon. In 1977 he had achieved, with an experimental car, two hundred miles per gallon.

That kind of innovation would naturally attract the notice of investors, and others who would never want to see that kind of technology seeing the commercial light of day.

On August 19, 1981, Ogle saw his last light of day. He died at the age of twenty-six.

His death was supposedly due to an overdose of alcohol and pain pills, but many didn't believe it. Why would an individual with that kind of talent, and the kind of technology with interested investors take his own life?

It doesn't take much imagination to figure out why certain corporate interests would want to take Ogle's life and make it look like either a suicide or an accident.[2]

How about another example about an inventor who was too inventive for his own health?

#### You may have heard of him — Nicola Tesla.





**Health or legal specifics:** If you're discussing sensitive topics related to health or legal matters, remember that AI can't replace professional advice and isn't bound by the same confidentiality protections.

**Proprietary information:** If you're working on something confidential, such as a project or idea, avoid sharing detailed, sensitive details.

**General rule:** If you wouldn't want your information shared elsewhere, it's best to keep it to yourself.

# The Five Things You Shouldn't Tell ChatGPT

Don't let your mystery rash become AI training fodder—or turn up in a data breach

I've learned a lot from OpenAI's ChatGPT over the past few years. And the bot has learned a lot about me.

The AI picked up factoids from our many conversations and banked them in its memory. It remembered I like eggs, I have a baby who nurses to sleep and I need to modify my exercise because of my achy back.

It also remembered even more personal things I won't repeat here.

It doesn't matter which chatbot you choose: The more you share, the more helpful they can be. Patients upload their blood work for analysis and engineers paste snippets of unpublished code for debugging help. Some AI researchers say we should be more discerning about what we tell these human-sounding tools. Some information is especially risky to share, such as your Social Security number or your company's proprietary data.

The AI companies are hungry for data to improve their models, but even they don't want our secrets. "Please don't share any sensitive information in your conversations," OpenAI urges. And Google implores its Gemini users: "Don't enter confidential information or any data you wouldn't want a reviewer to see."

Chats about your weird rash or your financial flubs might be used to help train tomorrow's AI—or come out in a data breach, say AI researchers. Here's what to keep out of your prompts, and how to have more private conversations with AI.

#### Keep these confidential

Chatbots can sound eerily human, leading people to be surprisingly open in their conversations with them. When you type something into a chatbot, "you lose possession of it," says Jennifer King, a fellow at the Stanford Institute for Human-Centered Artificial Intelligence.

In March 2023, a ChatGPT bug allowed some users to see what other people initially typed in their chats. The company has since issued a fix. OpenAI also sent subscription confirmation emails to the wrong people, exposing users' first and last names, email addresses and payment information.

Your chat history could also be included in a hacked data trove or as a part of what's turned over if the AI company is served a warrant.

Protect your account with a strong password and multifactor authentication. And skip these specifics:

- Identity information. This includes your Social Security, driver's license and passport numbers, as well as your date of birth, address and phone number. Some chatbots work to redact them. "We want our AI models to learn about the world, not private individuals, and we actively minimize the collection of personal information," an OpenAI spokeswoman said.
- Medical results. Confidentiality is a core value in healthcare to prevent discrimination and embarrassment, but chatbots are typically not part of the special protection given to health data. If you're tempted to ask AI to interpret lab work, crop the image or edit the document before uploading: "Try to keep it just to the test results and redact it," King advises.
- Financial accounts. Guard your bank and investment account numbers, which could be used to monitor or access your funds.

- Proprietary corporate information. If you're using the mainstream versions of popular chatbots for work purposes, you could inadvertently expose client data or nonpublic trade secrets—even with something as small as drafting an email. Samsung banned ChatGPT after an engineer leaked internal source code to the service. If AI is useful in your job, your company should subscribe to an enterprise version, or have its own custom AI with companyspecific protections.
- Logins. With the rise of AI agents that can perform real-world tasks, there are more reasons to hand over account credentials to a chatbot. These services weren't built as digital vaults—save your passwords, PINs and security questions for your password manager.

#### Cover your tracks


When you give feedback about a bot's response—thumbs-up or -down, typically—you might be giving permission for your prompt

and its output to be evaluated and even used for training. If the conversation gets flagged for safety (if you mention violence, for example), company employees might review it.

Anthropic's Claude by default doesn't use your chats for training and deletes data after two years. OpenAI's ChatGPT, Microsoft's Copilot and Google's Gemini do use conversations, but offer an optout in settings. If you're privacy conscious, try these tips:

Delete often. Extra-paranoid users should delete every conversation after it's over, says Jason Clinton, Anthropic's chief information security officer. Companies typically purge "deleted" data after 30 days.

An exception? DeepSeek, which has servers in China. According to its privacy policy, it can retain your data indefinitely, and there is no opt-out offer.



ChatGPT's Temporary Chat keeps conversations out of your history—and out of OpenAI's model training.

**Use temporary chat.** ChatGPT's Temporary Chat, found in the top right corner of the chat window, is like your browser's Incognito Mode. Turn it on to stop ChatGPT's memory bank from adding that material to your profile. The chat won't appear in your history, and the contents won't be used to train models.

Ask anonymously. Duck.ai, by privacy search engine DuckDuck-Go, anonymizes prompts to the AI model of your choice, including Claude and OpenAI's GPT, and says data isn't used for model training. It can't do everything a full-service bot can, such as analyze files.

Just remember: The chatbots are programmed to keep the conversation going. It's up to you to hold back—or hit "delete."

His student loan forgiveness plan is unprecedented. Unilateral executive action of this scale has never occurred during peacetime. Moreover, Congress, not the president, is supposed to make spending decisions of this magnitude.

Even Obama's former chief economic advisor, Jason Furman, criticized Biden's move, calling it:

# "Pouring roughly half a trillion dollars of gasoline on the inflationary fire that is already burning—reckless."

Beyond the inflationary impact—which I'll address shortly—Biden's student loan jubilee will set a precedent that will be hard to undo.

Consider how those who acted prudently feel. Many avoided student debt by choosing less expensive career paths, cutting back on spending to pay for college without borrowing, or paying off their student loans entirely.

#### These people are probably feeling like suckers now.

Not only do they receive no relief, but they also face the burden of footing the bill for those whose loans will be forgiven.


I imagine these people will be angry and probably have considerable car, mortgage, and credit card debt, as many Americans do. So they will want debt relief, too... and I bet they will get it.

Amid rising prices, consumer debt is skyrocketing. It is at an all-time high of nearly \$18 trillion, as seen in the chart below.

# With interest rates rising recently, the cost of servicing this record debt is becoming unbearable for many.

As Americans hit their financial breaking points, I be-

lieve debt forgiveness demands will only grow louder—extending far beyond student loans.



#### All it takes is a President's pen stroke to wipe out hundreds of billions in debt.

The student loan jubilee will set a powerful precedent. I don't think it will be long before we see a credit card jubilee, a car loan jubilee, or even a mortgage jubilee. How will the government pay for all these jubilees?

Raising taxes enough to cover them seems improbable.

Issuing more debt to cancel other debts would be contradictory.

That leaves money printing as the only viable option.



#2 According to a new CNBC/SurveyMonkey poll, a whopping 73 percent of U.S. consumers admit that they are "financially stressed"...

Americans are growing increasingly uneasy about the state of the U.S. economy and their own personal financial situation in the face of stubborn inflation and tariff wars.

To that point, 73% of respondents said they are "financially stressed," with 66% of that group pointing to the tariff wars as a main source, according to a new CNBC/SurveyMonkey online poll. The survey of 4,200 U.S. adults was conducted April 3 to 7.

#3 Approximately two-thirds of U.S. adults feel like they are "behind on their savings goals", and half of U.S. adults believe that they will never reach their savings goals at all...

67% of Americans feel behind on their savings goals, with nearly half (47%) believing they'll never reach their targets

#4 More than 60 percent of U.S. adults that currently have savings accounts have taken money out of them since the start of this year...

63% of people with savings accounts have withdrawn money since the beginning of 2025, primarily for unexpected expenses (48%) and everyday necessities (36%)

#5 The percentage of U.S. credit card accounts that are at least 90 days past due has reached the highest level in 12 years...

The percentage of credit card accounts that were at least 90 days past due hit a 12-year high in the fourth quarter of 2024.

According to data from the Federal Reserve Bank of Philadelphia, 0.90% of accounts were delinquent, the most since the Fed bank began its report.

#6 5 million student loan borrowers in the United States have not made a single payment in the last year, and 4 million other student loan borrowers will soon reach that status...

Of the more than 42.7 million student loan borrowers in the U.S., who owe a collective \$1.6 trillion, the department says that more than 5 million have not made a payment in the past year. That number is expected to grow as an additional 4 million borrowers are approaching default status.

#7 For the first time in about 5 years, the Department of Education "will resume collections of its defaulted federal student loan portfolio". This is going to put additional financial stress on millions of U.S. households...

The U.S. Department of Education today announced its Office of Federal Student Aid (FSA) will resume collections of its defaulted federal student loan portfolio on Monday, May 5th. The Department has not collected on defaulted loans since March 2020. Resuming collections protects taxpayers from shouldering the cost of federal

student loans that borrowers willingly undertook to finance their postsecondary education. This initiative will be paired with a comprehensive communications and outreach campaign to ensure borrowers understand how to return to repayment or get out of default.

#8 The average credit score in the United States just dropped at the fastest pace since the Great Recession...

America's credit score just took its biggest hit since the 2008 crash.

The average FICO score in the US has dropped to 715 from 717 the largest one-year drop since the Great Recession, according to new data from the credit-rating giant FICO.

#9 U.S. consumers are eating out less, and as a result restaurant chains all over the country are in financial distress...

Once rapidly growing commercial marvels, casual dining chains sit-down restaurants where middle-class families can walk in without a reservation, order from another human and share a meal have been in decline for most of the 21st century. Last year, TGI Fridays and Red Lobster both filed for bankruptcy. Outback and Applebee's have closed dozens of locations. Pizza Hut locations with actual dining rooms are vanishingly rare, with hundreds closing since 2019.

According to a February survey by the market research firm Datassential, 24 percent of Americans say they are having dinner at casual restaurants less often, and 29 percent are dining out less with groups of friends and family.

#10 U.S. consumers are visiting shopping malls a lot less than they once did, and as a result many mall retailers are going belly up...

Merry Go Round, Bon-Ton, Lord & Taylor, The Limited, Loehmann's, Bonwit Teller, Chess King, and Anchor Blue are just a few once-successful clothing retailers that no longer exist.

Now, a once-trendy fashion/clothing retailer finds itself having to make massive cuts and shut down 100s of stores in a fight to avoid bankruptcy.

#11 U.S. consumers are not spending as much money at hair salons, and Bloomberg is telling us that this is an indicator that a recession is coming...

Stylists from Manhattan to rural New Hampshire are seeing regular clients start to skip cuts and blowouts. In from the Maine town of

Brewer, hairstylist Alyssa Dow said customers are choosing cheaper, "more low-maintenance" looks—and tipping less. In affluent Longmeadow, Massachusetts, where "people don't like to walk around with roots" showing, clients who previously got color every two or three weeks are stretching it to four or five, citing the "political situation" and implying they've lost money in the stock market, said Michelle LaValley. "They're cutting back in other areas as well, so it's not just us," said the salon owner, who has 28 years in the business. The wider pullback in spending seems to go beyond the general grumpiness that accompanied the so-called vibecession that started years ago when inflation rose, interest rates spiked and yet the US kept growing.

#12 According to the Fed, U.S. consumers are becoming more concerned about inflation and unemployment...

The central bank's monthly Survey of Consumer Expectations showed that respondents saw inflation a year from now at 3.6%, an increase of half a percentage point from February and the highest reading since October 2023.

Along with concerns over a higher cost of living came a surge in worries over the labor market: The probability that the unemployment rate would be higher a year from now surged to 44%, a move up of 4.6 percentage points and the highest level going back to the early Covid pandemic days of April 2020.

We have new research on the brain that has arisen in the past three years. But the research is voluminous and scientists and cognitive researchers are going crazy on this point. Basically, we now have discoveries about the brain, specifically a part of the brain called the Anterior Midcingulate Cortex (aMCC) )and this part of the brain will explain why America will probably never overcome the deep state Communist takeover of this country. But is it correctable? Yes, but that's not how our nation is geared.

The Anterior Midcingulate Cortex. This is new research. When I taught brain Physiology in a class called biological psychology, this wasn't part of the course. This was not in the curriculum because this stuff was not yet known. But it's absolutely amazing. When you use a part of the brain, the brain grows and becomes more functional in that area. When you don't use that part of the brain, the brain shrinks and it becomes a problem with cognition and whatever area it's related to. The same principles apply here as well.

Now, the Anterior Midcingulate Cortex is located in two different parts of the brain. In the left hemisphere and the right hemisphere. Now here's what this is about, and this is just got scientists scratching their heads. They believe this is just amazing. But the data is overwhelming. When you do something you don't like, this part of the brain grows. So let's say you refuse the chocolate cake when you're on a diet. Let's say that you're lifting weights and you go to failure on your last set. Let's say you push yourself to study extra hard for that exam, even though you don't like the material. Pretty interesting, isn't it?

Now here's the deal. This is really really interesting. How's American Society geared? Are we geared towards hard work? Diligence, staying with the task, no matter what. Are we geared that way? No, quite the contrary. We're geared for the dopamine, serotonin high,

the adrenaline rush. Chocolate and sex. There's nothing wrong with that. Life is pleasurable in some ways and we should enjoy the pleasure. Of course, everything in moderation as they say. But America is obsessed with living in the moment and feeling good in the moment. We don't have the work ethic as a nation that does what this does.

Now let me back up. It's not an accident that the two greatest generations in American history came through terrible times. I'll give you an example. It was the upper middle class and upper class merchants in this country that led the rebellion against Britain in the Revolutionary War. But during the war, these people didn't live upper middle class and upper class lives. They were always in trouble. Always in danger, always living kind of a deprived life and hope for a better life. And some of the people that participated in the revolution, the same thing. Remember Valley Forge. Need we say more? These people were forced to do things they didn't want to do. And if we had the technology, then we could have measured the Anterior Mideingulate Cortex and see that they were above average.

Now who's the other generation that really made America great? That would be the Depression, World War II generation. I think there's no debate about that. Look at the prolonged number of years people were forced to do things they did not want to do. For example, men 18 to 30, they might go to work on the public works project or the Civilian Conservation Corps. They had to leave home, send money home to support the family. How do you think his arms felt after about an hour? But he kept going and kept going. He understands this and if it's hard, he wants to embrace it.

We used to do that kind of thing. "Go West, young man." Do you think those were pleasant journeys for the Pioneers? Of course not. Covered wagons would break down, horses would break an ankle. You'd have all kinds of challenges. You would have to do things you don't want to do. And we had tough people in the West. And that formed part of our character. Turner's thesis is based on the progressive levels of settlement that came to the West and how these people did very difficult things to establish America on the frontier. We don't go there because it's glamorous or it's fun. We go there because it's hard. He understood this. Of course he didn't know about the brain Physiology, but he understood about the concept. And military training is based on this. They make you do the hard thing even when the hard thing doesn't make sense because

they want to turn you into a survivalist warrior. It's about survival.

Then there is the group behind the Georgia Guidestones. These granite monoliths were America's version of Stonehenge. They were built in 1980 by a mystery group led by R.C. Christian – whose real name also remains a mystery.

But its goals were no mystery. If you visited Elberton, Georgia to see the granite monoliths in person, you would have found ten messages engraved in the granite. And in case you weren't from America, the messages were repeated in eight different world languages and 4 dead languages, including Sanskrit.

R.C. Christian really wanted you to read his tenants. He believed they were guides to a utopian future (thus the name Georgia Guidestones). The very first message read, "maintain humanity under 500 million in perpetual balance with nature".

Farming, manufacturing, shipping, constructing – when elite groups imagine a utopia, they don't imagine they're navigating a container ship across the Atlantic, or harvesting strawberries, or any number of things that take real work.

This month March 2025, DBS – Singapore's largest bank – announced plans to reduce its workforce by  $4{,}000$  people over the next four years. Not because it figured out how to do the same with less work. The plan is to do more.

The bank is replacing humans with artificial intelligence. The bank deploys over 800 AI models already, and expects to see over a billion dollars in added revenue from the move to replace human beings.

Swedish financial tech company Klarna went one better. It stopped hiring any humans with the goal of replacing all workers with AI. Already its AI assistant, which is powered by OpenAI, is doing the work of 700 full-time customer service agents.

And there's more. According to Bloomberg, global banks are planning to cut 200,000 jobs in the next five years as artificial intelli-

gence takes on jobs formerly done by humans.

The International Monetary Fund warned that AI will likely take 40% of all jobs worldwide. A CNN survey of finance chiefs confirmed US firms are on board, with 61% planning to use AI to automate tasks done by employees.

Elon Musk, the man currently tasked with cutting thousands of U.S. Government jobs, has already seen where this all goes. Speaking at the UK's AI Safety Summit in 2023, the Tesla CEO said he believes AI will "replace the need for all jobs".

The message engraved in the 16-foot-tall Georgia Guidestones sounded crazy – that we could keep the population to 500,000. Yet, the world seems to be preparing for a time when there won't be so many humans around.

On April 3<sup>rd</sup>, Donald Trump announced it as "Liberation Day", and by that he meant we were going to be liberated from the asymmetrical tariffs of the last 50 years. I thought tariffs destroyed an economy? But they seemed to like them, and they're angry that they're no longer asymmetrical. Apparently, people who impose tariffs on us think tariffs improve their economy. Maybe they are right. I don't know.

The second thing is why would you get angry at the person who is reacting to the asymmetrical tariff and not the people who inaugurated the tariff? Why is Canada mad at us when it's running a \$63 billion surplus and has tariffs on some American products at 250%? Doesn't it seem like the people who started this asymmetrical, if I could use the word "trade war" should be the culpable people, not the people who are reluctantly reacting to it? Sort of like Ukraine and Russia. Russia invaded Ukraine. Do we blame Ukraine for defending itself and trying to reciprocate? No, we don't. We don't blame America because it finally woke up and said whatever they tariff us we're going to tariff them.

Which brings up another question. Are our tariffs really tariffs? That is, were they preemptive? Were they leveled against coun-

tries that had no tariffs against us? Were they punitive? No, they're almost leveled on autopilot. Whatever a particular country tariffs us, we reciprocate and just mere image them and they go off anytime that country says "You know, it was a mistake. We're sorry. You're an ally. You're a neutral. We're not going to tariff this American product and then we say fine. Then the autopilot ceases and the automatic tariff ends. In other words, it's their choice, not ours. We are just reacting to what they did, not what we did.

Couple of other questions that I've had. We haven't run a trade surplus since 1975, 50 years ago. So it wasn't suddenly we woke up and said it's unfair, we want commercial justice. No, we've been watching this happen for 50 years. It's been going on and no president or no administration, no Congress in the past has done anything about it. Done anything about what? Leveling tariffs on our products that we don't level on theirs. It was all predicated in the post war period. We were so affluent, so powerful. Europe, China, Russia was in shambles, that we had to take up the burdens of reviving their economies by taking a great trade deficit. Fifty years later, we have been deindustrialized. And the countries who did this to us by these unfair and asymmetrical tariffs did not fall apart. They did not self-destruct. They apparently thought it was in their self-interest. And if anybody calibrates the recent GDP growth of India or Taiwan or South Korea or Japan, they seem to have some logic to it.


There's a final irony. The people who are warning us most vehemently about this tariff quote the Smoot Hawley Act of 1930. But we must remember something, that came <u>after</u> the onset of the depression, after the stock market crashed in 1929. That law was not passed untill 1930. It was not really implemented until 1931. And here's the other thing that they were conveniently not reminded of. We were running a surplus. That was a preemptive punitive tariff on our part against other countries. We had a trade surplus and it was not 10% or 20%. Some of the tariffs were 40% and 50%. And again it happened after the collapse of the stock market.

In conclusion, don't you find it very ironic that Wall Street is blaming the Trump tariffs for heading us into a recession, if not depression, when the only Great Depression we've ever had was not caused by tariffs but by Wall Street?

Examples of countries that are experiencing Christian Ultranational-

Spain, under Francisco Franco (1939-1975), promoted a strong connection between Spanish nationalism and Catholicism

Russian (Contemporary), the Russian Orthodox Church shapes national identity with the government promoting a sense of national unity and moral authority

United States (various periods), although not officially adopting Christian nationalism, certain movements and political groups have sought to intertwine Christianity with American identity, especially considering that the country was founded on Christian values.

**Poland (Contemporary)**, the government emphasizes its Catholic heritage as central to national identity, influencing policies and cultural narratives.

"Peter Zeihan here coming to you from Scottsdale, Arizona. Since we started the Russian Reach Youtube series, a lot of you have been writing in with little tips, information that you've got from within the government system right up into the White House, which is kind of crazy. An alternative theory that might match the facts in front of us is I think worth exploring a little bit and its called Christian nationalism. Really what it is is ultra nationalism. It's the idea that there's this global cabal out there that is working to undermine and eradicate the white race. It tends to be obviously wildly racist, opposed to immigration and pretty much all forms of people unless they're

white people. It's very violent and distrusts any sort of large organization. They generally hate Catholics, specifically the Pope; and Muslims are worse. And as a rule, they think that Western civilization has been corrupted or controlled from within by these larger forces and so all of Western civilization needs to be torn down to the studs and then rebuilt with a fusion of church and state. Of course, there's no agreement as to what "church" means. So really it's just a cover for people to be wildly racist and say that white people should be in charge. Specifically, powerful white people.

Within the American administration, the four biggest influencers would be Russ Vaht at the OMB, Elon Musk, of course, and then on the outside looking in is Peter Thiel. Then JD Vance, the vice president is a member of this general group. It's not even a club, but a worldview. And that kind of gives you an idea of just how flexible the ideology of Christian ultra nationalism is. It's, you know, JD Vance is a Catholic, although a practically evangelical Catholic. Elon Musk is practically agnostic. Peter Thiel is gay. It's kind of a big tent with a lot of ideas. All I can really say that it kind of draws it all together and there's nothing about it that's actually Christian. I'm no theologian, but I'm fairly certain that there's a nice hot spot on the other side of the veil for people who try to actually put this into practice. Anyway, there are some commonalities here that kind of run the rainbow with this group that everybody agrees on.

There are two countries in particular that they're just obsessed about, and the first is South Africa because here is a country that white people brought civilization to and clearly with the end of apartheid and the return of majority rule by blacks, clearly this is part of an effort by the globalist cabal to test out white genocide. When Donald Trump picked a fight on a random Tuesday with the South African government and then just completely came out of the blue, it was rooted on by these groups specifically Elon Musk, who was born in South Africa.

The other country that the ultra nationalists are really obsessed with is Russia. They see Russia as fighting the good fight and its demographic collapse as a warning to white people everywhere of what could happen if the Muslim horrors are allowed to rise up. And as a result, Christian ultra nationalists are pretty much pro Russian, no matter what the Russians do. It's people using religion as a cover to do horrible things (not that we've ever seen that before).

But the reason it's worth talking about is not only are some of these people very well placed within the current administration, but there's a lot of overlap between Christian ultra nationalism and Russian propaganda these days. The Russians are very well aware of this trend, and they've worked to encourage it across Europe and the United States for quite some time and a lot of their useful idiots

throughout the US and the European political systems followed its Christian nationalist camp. I'm sure you can all come up with a few names yourself if you put your minds to it.

The idea that Russia is beleaguered and needs assistance and should be respected as something that dovetails very nicely with the Russian mindset. Every country has their own reason why they think they're better than everyone. And for the Russians, they have a superiority complex that is based on an inferiority complex. The idea is that we have suffered so much, therefore, you should do things our way. It's very powerful for motivating Russians, and now it's being repeated basically by these Christian ultra nationalists. And so whether the issue is going after U.S. intelligence, part of the cabal, going after the European Union, part of the cabal, or simply trying to give the Russians what they want in places like Ukraine, fighting back against the cabal, the Russians have done what they can to dovetail their existing propaganda with these forces. So yeah, it can be both. Not just the Russians, but trying to dovetail with a more domestically oriented group that is trying to use a bastardization of religion to achieve its political goals."

This system, praised by many as a technological breakthrough, is quietly forcing millions to submit to full digital registration simply to function in everyday life.

At first this might look like progress. News outlets called it a step toward efficiency, modernization and inclusion. But to those with spiritual eyes AADHAR\_represents something far more sinister. Perhaps it is the prototype of the beast system described in Revelation 13. A local pastor in India once said with deep sadness, we are entering the

Book of Revelation through the front door. His words reflect what many believers in India are beginning to feel, a growing sense of spiritual oppression, not through violence or persecution alone, but through technology. Consider, when every detail of your life is linked to a centralized system controlled by authorities, how easy would it be to silence voices that challenge the system? How quickly could people practicing a religion be flagged as dangerous or non-compliant simply for refusing to compromise their faith?

Even more disturbing is how willingly the people embraced this system. There were no massive protests, no national outrage. Instead, there were long lines at registration centers, excited social media posts and a cultural celebration of technological advancement. But what many fail to see is that this is exactly how prophetic systems work. They don't begin with chains, they begin with convenience.


