July 1, 2025, the new Name, Image, and Likeness (NIL) rules officially went into effect, marking a major shift in

college athletics. Here are the changes: Schools can now pay athletes directly through a revenue-sharing model, bypassing third-party NIL collectives; Each Division I school can allocate up to \$20.5 million annually to athletes, starting in the 2025–26 academic year;

These payments are in addition to scholarships, not replacements; There's no mandated breakdown by sport, but many schools are expected to funnel the majority into football and men's basketball; A new clearinghouse called NIL Go, run by Deloitte, will monitor third-party NIL deals to ensure fair compensation; It's a landmark moment — not just for athletes, but for the entire structure of collegiate sports.



July 1, 2025 The University of Pennsylvania apologized and took corrective action regarding Lia Thomas's participation in women's swimming. Terms of agreement: Penn agreed it will no longer allow transgender women to com-

pete in women's sports programs; Restoration of Records: All Division I swimming records and titles previously held by Thomas will be restored to the female athletes who were displaced; Apology Letters: Penn will send personalized apology letters to each affected swimmer; Policy Changes: The university must adopt "biology-based" definitions of male and female for athletic eligibility; University's Statement; Penn President J. Larry Jameson acknowledged that while the university followed NCAA rules at the time, "some studentathletes were disadvantaged" and the school would apologize to those impacted; This resolution is part of a broader federal push to redefine eligibility in women's sports based on biological sex.



July 2, 2025, the Federal Trial Court in New York announced its Verdict in the Sean "Diddy"

Combs case. Guilty on two counts of trans-

portation to engage in prostitution under the Mann Act and Not Guilty on: Racketeering conspiracy and two counts of sex trafficking (involving Cassie Ventura and another woman **identified as "Jane").** The charges stemmed from allegations that Combs transported former girlfriends and sex workers across state lines for prostitution. The jury deliberated for three days after a seven-week trial featuring 34 witnesses, including celebrities like Kid Cudi and Combs' ex-girlfriend Cassie Ventura. Prosecutors alleged a pattern of coercion and abuse; the defense argued the relationships were consensual. However, Judge Arun Subramanian denied Combs' request for bail, citing a "pattern of violence" and concerns for community safety. Combs will remain in custody at Brooklyn's Metropolitan Detention Center until sentencing, which is scheduled for October 3, 2025. Combs faces up to 20 years in prison, though legal analysts suggest a sentence of 4–10 years is more likely.



July 3, 2025, President
Trump's "One Big, Beautiful
Bill"—a sweeping tax and
spending package—narrowly
passed the House by a 218—
214 vote, after clearing the
Senate two days earlier with
Vice President JD Vance cast-

ing the tie-breaking vote. The President will sign the bill into law on July 4. Breakdown of what's in the bill and what it means: **Major Tax Changes:** Extends and expands the 2017 Trump tax cuts, which were set to expire in 2025. New deductions: Up to \$25,000 in tips and \$12,500 in overtime income (or \$25,000 for joint filers), \$6,000 deduction for seniors earning under \$75,000, Deduction for interest on new vehicle loans, if the car is assembled in the U.S., Child Tax Credit increased to \$2,200 per child, up from \$2,000, Standard Deduction raised to \$31,500 for families, SALT deduction cap raised from \$10,000 to \$40,000 through 2030, Spending Cuts & Safety Net Changes: Medicaid: Over \$1 trillion in cuts over 10 years, with new work requirements for able-bodied adults, SNAP (food stamps): Tighter eligibility rules, especially for adults with older children, States must cover more costs if their SNAP error rates are too high, CBO estimates up to 11.8 million people could lose health coverage by 2034, Border & Immigration Enforcement, \$46.6 billion for border wall construction, \$29.9 billion for ICE operations, including hiring 10,000 new agents, \$45 billion for new detention facilities, This would make ICE one of the most well-funded law enforcement agencies globally, Climate & Energy Rollbacks: Ends EV tax credits (up to \$7,500) on September 30, 2025, instead of 2032, Eliminates penalties for automakers violating fuel efficiency standards, Rolls back clean energy tax incentives from the Inflation Reduction Act, Debt & Deficit Impact: Adds \$4.5 trillion in tax cuts over 10 years, Spending cuts total \$1.2 trillion, leaving a projected \$3.3 trillion increase in the deficit, Republicans argue economic growth will offset the cost; critics call that "fantasy math", Political Fallout: All Democrats

opposed the bill; two Republicans voted against it, Critics say it favors the wealthy and undermines healthcare and climate policy, Supporters hail it as a historic tax cut and a win for working families



July 4, 2025, a catastrophic flooding near Kerrville and Ingram Texas, resulted in devastating loss of life and widespread destruction. Here are the key facts: Human Toll, At least 32 people have died and over two dozen remain missing

including, 23 to 25 girls from Camp Mystic, a private Christian summer camp along the Guadalupe River, remain unaccounted for, Victims include both adults and children, some found in vehicles swept away by floodwaters, Over 237 people have been rescued, many by helicopter. Over 1,000 personnel were deployed for search, rescue, and response operations, rescuing hundreds and performing over 160 airlifts.



July 7, 2025, President Trump declared that a 25% tariff would be applied to products entering the U.S. from Japan and South Korea, starting August 1, 2025. Trump sent letters with almost identical wording to

the leaders of Japan and South Korea, explaining that the tariffs were imposed because their trade relationships with the U.S. were imbalanced and lacked reciprocity. The tariffs follow a 90-day negotiating period with most goods taxed at 10%, amid ongoing high-level talks and legal challenges over Trump's authority to impose these duties. Trump cautioned that if other countries increase their tariffs in response, any such increases would be added on top of the existing 25% tariff rate that the U.S. imposes. These measures aim to pressure trading partners to accept more favorable deals, though concerns exist about economic slowdowns and impacts on international relations.



July 9, 2025, an unknown actor used an AI-generated voice and text messages to impersonate Secretary of State Marco Rubio via the encrypted messaging app Signal. The impersonator contacted at least five

officials, including three foreign ministers, a U.S. governor, and a member of Congress. The fake account used the display name marco.rubio@state.gov, which is not a valid government email. Intent & Impact: The goal appears to have been accessing sensitive information or manipulating recipients into believing they were speaking with Rubio. The impersonation was described as "not very sophisticated" and ultimately unsuccessful, but it raised serious national security concerns. Government Response: The State Department issued a July 3 cable warning diplomats and is now conducting a formal investigation. Officials emphasized the importance of using secure government platforms and are reviewing cybersecurity protocols. Broader Context: This follows similar AI-driven impersonation attempts, including one involving White House Chief of Staff Susie Wiles earlier this year. Experts warn that AI voice cloning scams are on the rise, with a reported 900% increase in AI-related fraud over the past two years.



July 10, 2025, U.S. District Judge in New Hampshire issued a nationwide block against President Trump's executive order restricting birthright citizenship. What the Order Did Trump's executive order, signed on February 19, 2025, aimed to limit birthright citi-

zenship to children born in the U.S. only if at least one parent is a U.S. citizen or lawful permanent resident. This would exclude children of undocumented immigrants, tourists, and temporary visa holders. Judge Laplante ruled the policy would cause "irreparable harm" by denying citizenship to children born on U.S. soil. He certified a class-action lawsuit on behalf of all children born in the U.S. after Feb. 20, 2025, whose citizenship would be denied under the order. He excluded parents from the class but said the risk to children alone justified nationwide protection. The ruling includes a seven-day stay, allowing the Justice Department time to appeal.



July 11, 2025, U.S. District Judge issued a ruling that temporarily halts federal immigration enforcement arrests in several California counties, including Los Angeles. The ruling stems from a lawsuit filed by the ACLU and immigrant rights groups, al-

leging that federal agents violated the Fourth and Fifth Amendments of the U.S. Constitution. The judge found a "mountain of evidence" suggesting that federal agents were conducting roving patrols without reasonable suspicion and denying access to legal counsel. Immigration agents are barred from conducting detentive stops unless they have reasonable suspicion that the person is violating U.S. immigration law. Agents cannot rely solely on factors such as: Race or ethnicity, Speaking Spanish or English

with an accent, Presence at certain locations (e.g., bus stops, car washes, day laborer sites). The Department of Homeland Security must provide access to legal counsel for detainees held in the downtown L.A. federal building. The ruling applies to seven counties in Southern California and was supported by cities like Los Angeles, Pasadena, Santa Monica, and others.



July 12, 2025, President Trump announced the 30% tariff on goods from the European Union and Mexico with implementation set for August 1. Trump posted letters on Truth Social addressed to European

Commission President Ursula von der Leyen and Mexican President Claudia Sheinbaum, informing them of the new tariff rates. These letters were part of a broader wave of tariff notices sent to over two dozen countries, including Canada, Japan, and Brazil. Trump cited fentanyl trafficking and border security as the primary reasons for the tariff hike. He acknowledged Mexico's cooperation but claimed it was "not enough" to stop cartels from turning North America into a "Narco-Trafficking Playground"



On July 14, 2025, the Supreme Court issued its ruling allowing the Trump administration to proceed with mass layoffs at the Department of Education. The Court lifted a lower court injunction that had blocked the firing of approximately 1,400

Education Department employees. The ruling was 6-3 along ideological lines, with the conservative majority prevailing. The decision was issued as a brief, unsigned order with no explanation from the majority. Justice Sonia Sotomayor, joined by Justices Kagan and Jackson, issued a strong dissent, warning that the ruling gives the Executive Branch power to "repeal statutes by firing all those necessary to carry them out"



July 16, 2025, Maurene Comey, a federal prosecutor in the Southern District of New York, and daughter of former FBI Director James Comey was fired. She had served nearly a decade in the U.S. Attorney's Office and was involved in major prosecutions,

including: Jeffrey Epstein's sex trafficking case, Ghislaine Maxwell's conviction and Sean "Diddy" Combs' recent trial. The Justice Department gave no official reason for the teremination. Sources say the firing cited Article II of the Constitution, which

grants the president executive authority over federal employees. Her father, James Comey, was fired by Donald Trump in 2017 and has remained a vocal critic of the former president. Trump's administration is currently facing backlash from his own supporters over the handling of Epstein-related files. Some speculate that Maurene's dismissal may be politically motivated, especially given renewed investigations into James Comey. The DOJ recently released a memo stating there is no incriminating "client list" tied to Epstein, which has fueled conspiracy theories and internal disputes within Trump's circle.



July 16, 2025, The Trump administration officially revoked \$4 billion in federal funding for California's high-speed rail project, citing mismanagement, delays, and cost overruns. The project was designed to connect San Francisco and Los Angeles via a high-speed rail line. It was initially approved by California voters in 2008. Its estimated cost has ballooned from \$33 billion to over \$128 billion. The

current focus is on a 119-mile segment between Merced and Bakersfield, targeted for completion by 2033. The Federal Railroad Administration (FRA) concluded the project had "no viable path" to meet its goals on time or within budget. A 300-page compliance review cited: Missed deadlines. A \$7 billion funding gap. Overstated ridership projections. Inadequate contingency planning. Transportation Secretary Sean Duffy called it a "boondoggle" and said federal dollars should go to projects that "deliver results" President Trump labeled it the "High Speed Train to Nowhere" and declared the project "severely overpriced, overregulated, and never delivered" California Governor Gavin Newsom pushed back, calling the move "illegal" and a "gift to China", vowing to fight the decision and continue construction. California may seek private investment to fill funding gaps. Legal challenges are likely, as the state argues the federal grants were legally binding and obligations were met. The project remains active, with over 50 structures built and track-laying underway.



**July 18, 2025, the Trump** Administration rejected the World Health Organization's (WHO) pandemic-related reform on concerns over U.S. sovereignty, civil liberties, and international oversight. Health and Human Services Secretary Robert F. Kennedy

Jr. and Secretary of State Marco Rubio issued a joint statement citing: Risk of "narrative management, propaganda, and censorship" reminiscent of COVID-era communication controls. Concerns over digital health IDs and vaccine passports, which they argue could lead to global medical surveillance. Fear that the

amendments could allow an unelected international body to influence domestic health policy, including lockdowns and travel restrictions. A broader resistance to international bureaucrats shaping U.S. policy, especially in areas like speech, privacy, and personal liberties.



July 18, 2025, Fox News Digital published its report detailing allegations that the Obama administration "manufactured and politicized intelligence" to support the narrative of Russian interference in the 2016 nnel election. The following is what was reported: Director of National Intelligence Tulsi Gab-

bard declassified documents suggesting that Obama and senior officials—including James Clapper, John Brennan, James Comey, and Susan Rice—intentionally created a politicized intelligence narrative after Trump's 2016 victory. The documents claim that Russia was not attempting to influence the election via cyber means, contrary to later public assessments. Timeline of Events: Dec. 8, 2016: A Presidential Daily Brief stated that Russian actors did not impact the election results through cyberattacks, Dec. 9, 2016: A meeting in the White House Situation Room allegedly led to a directive to create a new intelligence assessment that would support claims of Russian interference, Jan. 6, 2017: A revised Intelligence Community Assessment was released, which contradicted earlier findings and included the discredited Steele dossier. Gabbard's Assertions: She described the effort as a "treasonous conspiracy" aimed at undermining the will of the American people and led to the Mueller investigation, congressional impeachments, and heightened U.S.-Russia tensions, Gabbard has referred the documents to the Department of Justice for potential investigation.



July 18, 2025, President Trump signed the GENIUS Act into law marking a major milestone in U.S. cryptocurrency regulation. GENIUS Act is the acronym for Guiding and Establishing National Innovation for U.S.

Stablecoins. It's the first federal law to create a regulatory framework for stablecoins—a type of cryptocurrency pegged to stable assets like the U.S. dollar. Consumer Protection: Requires stablecoin issuers to back coins 1:1 with liquid assets (like dollars or short-term Treasuries), publish monthly reserve disclosures, and undergo annual audits. Federal Oversight: Establishes clear rules for banks, credit unions, and private companies to issue stablecoins under federal charters. National Security: Subjects issuers to anti-money laundering laws and mandates technical capabilities to freeze or burn coins if legally required. Dollar Dominance: Aims to strengthen the U.S. dollar's role as the global reserve currency by driving demand for Treasuries through stablecoin backing. Trump called it "perhaps the great-

est revolution in financial technology since the birth of the internet" and joked that "they named it after me"



July 22, 2025, the new Trump-Japan trade deal is announced. Core Components of the Agreement: Tariff Reduction: The U.S. lowered tariffs on Japanese imports from a threatened 25% to 15%, especially benefiting Japan's auto industry. Japanese Investment: Japan committed to

investing \$550 billion in the U.S. economy, targeting sectors like semiconductors, pharmaceuticals, shipbuilding, and AI technologies. Market Access: Japan agreed to expand imports of U.S. rice, trucks, and agricultural goods, though rice remains within existing quota limits. Japan will drop additional safety tests for imported U.S. vehicles, a long-standing barrier to American auto sales. Market Reactions: Japanese Stocks Surged: Toyota and Honda shares jumped over 10%, and the Nikkei index rose by 3.5% following the announcement. Currency Volatility: The yen initially strengthened, then fell amid political uncertainty in Japan. Criticisms & Omissions: U.S. Auto Industry Pushback: Critics argued the deal favored Japanese imports over North American-built vehicles with higher U.S. content. Steel & Aluminum Left Out: The deal did not address the existing 50% U.S. tariffs on Japanese steel and aluminum. No Reciprocal Tariff Cuts: Japan did not reduce its own tariffs on U.S. goods beyond existing quotas. Timeline & Context: The deal was finalized just before an August 1 deadline for sweeping U.S. tariffs.. It followed months of tense negotiations and was part of a broader push by Trump to secure bilateral trade deals with key partners.



July 27, 2025, the 2025 Baseball Hall of Fame class was officially inducted. Inductees via Baseball Writers' Association of America (BBWAA), Ichiro Suzuki – First Japanese-born player inducted; received 99.7% of the vote, CC Sabathia – First-ballot inductee; 86.8% of the vote, Billy Wagner – Inducted on his 10th and final bal-

lot; 82.5% of the vote; Inductees via Classic Baseball Era Committee, Dick Allen – Posthumous induction; known for his power and bat speed, Dave Parker – Also inducted posthumously; passed away just weeks before the ceremony; Voting Highlights, Ichiro fell just one vote short of unanimous election, joining Mariano Rivera as the only player ever unanimously elected, Sabathia and Wagner surpassed the 75% threshold required for induction, Other notable candidates like Carlos Beltrán and Andruw Jones received strong support but were not elected.



July 27, 2025, the U.S. and the European Union reached a major new trade agreement, following months of tense negotiations and looming tariff threats. Key Details of the Agreement. Tariffs: The U.S. will impose a 15% tariff on most EU

goods, including cars, semiconductors, and pharmaceuticals; The EU will eliminate tariffs on U.S. industrial goods. Existing 50% tariffs on EU steel, aluminum, and copper will remain. Some strategic goods (e.g., aircraft, certain chemicals, semiconductor equipment) will face zero-for-zero tariffs. Energy & Investment Commitments: The EU will purchase \$750 billion in U.S. energy exports by 2028, The EU will invest \$600 billion in the U.S. economy over the same period, Additional purchases of U.S. military equipment are also part of the deal, Digital Trade & Non -Tariff Barriers: Both sides agreed to maintain zero customs duties on electronic transmissions, The EU will not adopt network usage fees, addressing U.S. concerns over digital trade barriers, Commitments were made to reduce red tape for U.S. exporters, especially small businesses, Strategic Implications: This deal averts a potential trade war and rebalances a historically lopsided trade relationship. It's being hailed as a generational modernization of transatlantic commerce, though some European leaders have voiced concern over the tariff burden.



July 28, 2025, The University of California announced that it had admitted its largest-ever class of international students for the upcoming fall term — a 17% increase over the previous year. This surge in international admissions was part of a broader strategy to offset uncertainties around visa approvals and

enrollment rates, especially amid increased scrutiny from the Trump administration. UC leaders aimed to maintain global diversity while also bolstering revenue through nonresident tuition. Most of the new admissions were to the Davis, Riverside and Santa Barbara campuses.



July 28, 2025, gunman Shane Devon Tamura from Las Vegas entered 345 Park Avenue, a high-rise that houses major firms like Blackstone, KPMG, and the NFL headquarters and opened fire in the lobby with an M4 rifle, killing three people, then moved to the 33rd floor, where he killed one more person before taking his own life. Tamura had a documented his-

tory of mental illness and left behind a rambling note suggesting a grievance against the NFL, possibly related to chronic traumatic encephalopathy (CTE). He traveled cross-country from Nevada, passing through Colorado, Nebraska, Iowa, and New Jersey




July 29, 2025, a powerful 8.8-magnitude earthquake struck off Russia's Kamchatka Peninsula, triggering widespread tsunami warnings across the Pacific. Key Details: Epicenter: About 125 km east-southeast of Pet-

ropavlovsk-Kamchatsky; Depth: 19.3 km (shallow, which increases tsunami risk); Impact: Shaking was intense in Kamchatka; buildings swayed, power outages occurred, and evacuations were ordered; Tsunami Alerts: Issued for Japan, Alaska, Hawaii, and parts of the U.S. West Coast, including California; Wave Heights: Up to 4 meters (13 feet) recorded in Kamchatka; Kamchatka Governor Vladimir Solodov called it "the strongest in decades of tremors"; Fortunately, early reports suggest no fatalities, though infrastructure damage and panic were widespread.



July 28, 2025, a tragic shooting at the Grand Sierra Resort in Reno; Overview of the Incident; A gunman opened fire near the valet area of the resort around 7:25 a.m; Three people were killed, and three others were injured, two

of whom remain in critical condition; The suspect, who had multiple magazines of ammunition, was shot by police and is currently hospitalized in critical condition; Sequence of Events; The shooter paced the parking lot for about 45 minutes before approaching a group and opening fire; After shooting five people at valet, he fled and fatally shot a driver passing through the lot; A security guard confronted him, and they exchanged fire; Reno police arrived within three minutes, engaged the suspect, and disabled him; Investigation Notes; Authorities say there's no known connection between the victims and the suspect; The motive remains unclear

f you live long enough, you get to see that what was once science fiction can become science fact.

It can be exhilarating. It can also be downright scary. And in the field of bio-robotics, where metal meets the meat of a man, it can be something deadly.

The dream of the super soldier is not new. The Spartans trained for war and little else. The story of the incredible fighting ability of the three hundred at Thermopylae is, well, legendary.

The Nazis created the SS, a supposedly superior human force of Darth Vader wannabes that dressed like extras from Star Wars. It was an attempt at creating a super soldier that read better than it played.

But now, advancements in robotics and medicine are working together to create a truly superior fighting man. It's a mixture of Robby the Robot and Rambo, and it isn't Darth Vader in charge, it's DARPA.

The Defense Advanced Research Projects Agency is putting in time to produce bio-robotic battalions for future wars.

Their website states:

'Recent advancements in — coupled with the convergence of — engineering and biology have propelled the development of biohybrid robots, which combine biological and synthetic components.'

DARPA is open to suggestions:

'DARPA is seeking ideas to address the question – How can synthetic and biological components be integrated to enable biohybrid platforms that outperform traditional robotic systems?'

That describes improving machines with biological elements, but how far is that from enhancing humans with mechanical elements – and not just in terms of prosthetics?

Not that far. Back in 2014, DARPA was researching the 'warrior web' which:

'While protecting against injury, Warrior Web also seeks to make Soldiers into better performers by giving them the feeling of a lighter load and enhancing their existing physical capabilities.'

The researchers were 'exploring technologies to augment muscle work and increase Soldier capabilities.'

A 2017 report, Developing the Super Soldier: Enhancing Military Performance stated:

'increasing effort is being placed on creating soldiers whose performance exceeds natural limits. Whereas soldiers are most certainly human, this effort has become known as human performance enhancement.'

The report makes reference to:

'efforts by the Defense Advanced Research Projects Agency (DARPA) to allow humans to control robotic systems through a neural interface that connects directly to the brain, even to the

point of allowing the human to "feel" what the robot touches.15 Though currently this research has mostly been applied to aiding amputees control robotic prostheses, this technology could conceivably enable soldiers to control robotic weapon systems remotely, thus limiting their exposure to risk.'

This was an unclassified report, but some of the language might be instructive as to what really might be going on. Phrases like 'mostly been applied' and 'could conceivably' suggest we might assume the opposite of the quote is what's really going on, and the research is mostly being applied to creating a super soldier.

It makes sense in a world where robotics is playing a growing role in warfare. Inexpensive drones are destroying expensive armored vehicles. Robot dogs are on the battlefield. Robotic systems are shooting at the bad guys in urban areas.

Modern military forces increasingly let the machines do the heavy fighting while humans operate the systems from a distance. From the perspective of a soldier, this is a great idea.

But when we are engaged in military transhumanism — the evolution of the human solider through technological fusion with body and mind – any rules of war or ethical guidelines that might exist could disappear.

On the other hand, if the marriage of man and machine can aid the human soldier in his task, then why not? For example, with respect to the robotic assistance that is not invasive with respect to the human being:

'To help alleviate physical weight on troops DARPA is developing a for legged robot, the Legged Squad Support System (LS3) to integrate with a squad of marines or soldiers.'

But the moral, ethical and technological questions really arise when the enhancements of technology are invasive, and become a part of the human being, making him a bio-robot.

In an October 2023 report, 'Neuroethical Framework to Analyze Soldier Enhancement Using Invasive Neurotechnology,' authored by Lieutenant Commander Vincent J. Chamberlain III of the United States Nave, it was recognized, neurotechnology:

'can change what it means to be human for a healthy soldier. It is unlikely that researchers can all of the possible second and third order consequences of invasive neurotechnology before implanting it in soldiers.'

In the report, a truly frightening potential for invasive neurotechnology was referenced, even though the stated purpose was to eliminate PTSD for soldiers:

'Some neurotechnology research is designed to erase certain events from the memory of soldiers to prevent post traumatic brain disorder.'

That same technology could be used to create a real live 'Manchurian Candidate.' It could be used to remove any ethical concerns or moral considerations in the human bearing the bionic part.

Why You Should Care

Non-invasive enhancements to soldier performance are primarily a good thing. Anything lightens their burdens on the battlefield or reduces injury or death is a benefit.

These innovations continue a trend of technology helping soldiers – from more powerful weapons and greater protect gear to faster methods of medical evacuation and medical treatment.

But invasive neurotechnology has the potential to change a soldier's ethical and moral makeup, or even eliminate pieces of his memory. That should raise some concerns.

The world has seen the results of the complete elimination of morality from the military. Nine million innocents saw it firsthand in Nazi Germany.

While much of basic military training tends to make an individual more robotic — witness marching and close order drill — it is not designed to eliminate the human from the being. Technology that manipulates emotion or memory could do just that.

Neuro-electronic and pharmacological technologies exist to remove fear, compassion, and any other emotion that could hinder a soldier's performance.

This might be effective and efficient. However, it could be nightmarish to realize that in creating a super soldier, we have at the same time, created a monster.

As what is first developed in the military quickly trickles down to the civilian world, what brave new world might be created? What benevolent human tendencies might be destroyed?

## The challenge with global warming may not be our ability to adjust to the hotter climate, but the deadly toxins that thrive in it.

Millions of people will die from viral infections this year. You know their names – the killers are infamous. They make the front page: COVID-19, Ebola, rabies, influenza, hepatitis, measles, yellow fever, polio, HIV – it's a familiar if detestable list.

We have massive resources devoted to stopping viruses. Some have been basically eradicated. Mainstream science has given us vaccines for nine of the deadliest threats. And efforts continue to find them for the other two (HIV and hepatitis C).

But there are other killers floating in the air, with names like Aspergillus and Cryptococcus. They don't make headlines. But they kill over 1.5 million people a year.

They are fungi. And guess how many have an approved vaccine? Zero.

Less than 10 percent of the 4 million fungi species on the planet have even been described, let alone genetically sequenced for vaccine research.

We are flying blind to what species of fungal toxin might be growing out there.

Why the blind spot? Fungi love tropical or subtropical regions, and they feast on humans with weakened health conditions. In other words, low-income countries in the Third World.

The developed world – North America, Western Europe, and Australia – just don't see these outbreaks. At least, we didn't used

There's growing evidence that while we ignore the Third World, its climate is coming to us.

In 2012, a deadly fungus invaded Iowa. The state had one of the hottest summers on record in the U.S., leading to a severe

Where usually summer in the Iowa farmland hits 85F, 2012 saw temperatures soar to 108 degrees for weeks. Suddenly, the climate was ideal for the fungus Aspergillus. The corn crops were infected with elevated levels of aflatoxin, the toxic chemical produced by the fungus in these extreme conditions.

The FDA caught it in time. Shipments of grain were rejected due to dangerous levels of aflatoxin. Corn had to be removed from the supply chain before it was fed to animals, which would end up being food for American consumers.

The economic losses for farmers nationally from the outbreak exceeded \$1 billion. But the contamination was stopped before it entered the human food chain in any form.

It's a good thing. Aflatoxin is a dangerous, cancer-causing poison that hides in food. We would have never known.

And consumed at the levels found in the grain that summer, it could cause acute liver damage leading to vomiting and jaundice and even liver failure. For children or people with underlying health conditions it would be fatal.

The incident was a wakeup call.

And a study published last month (May 2025) by the University of Manchester indicates the danger is only getting worse. The paper is based on fungal DNA data collected in an international database, along with future climate modeling, to study climate change-driven shifts in aspergillus habitats.

Based on their modeling, rising global temperatures will alter ecological niches – places where these fungi live now because the climate is a perfect match. As extreme weather events like Iowa's 2012 drought happen more frequently, the distribution of the aspergillus species will spread.

Fungal spores will increase in the air in developed countries, their pathogens spreading freely.

According to the study, as temperatures rise in Europe, Asia, and the Americas, a killer fungus will spread, causing fatal lung problems for vulnerable people and infecting millions.

While inhaling the fungus's spores does not make everyone ill, those with conditions such as asthma, cystic fibrosis or a weakened immune system remain at risk. Most disturbingly, the species grows quickly in high temperatures and loves the 98.6F internal temperature of the human body.

Ironically, in the Midwest they currently have pesticides that act as antifungals, clearing the crops of the toxin. But the more the pesticides are used, the stronger the fungi evolve to overcome them. By the time climate shifts and Aspergillus arrives, the pesticides may no longer have any effect on the toxin.

Researcher Norman van Rhijn, co-author of the study, warns that, "the world is approaching a tipping point where the spread of fungal pathogens could become the norm." According to Rhijn, "We're talking about hundreds of thousands of lives, and continental shifts in species distributions."

Let's look at some examples where the pills we are prescribed make you unsure if you want to take the cure...

High Cholesterol, besides being a common condition, is a great generator of profits for the pharmaceutical industry. Pfizer promoted its drug, Lipitor®, now off patent, as a valid treatment for this condition.

It was; it could lower cholesterol. It could also do other things

which were a consummation not devoutly to be wished.

Lipitor® was the proprietary name for *atorvastatin*. Besides lowering your cholesterol, it could make you nauseous and give you headaches, cause nosebleeds, sore throat, and a choice between constipation or diarrhea.

That's just the easy stuff. There were potentially much more serious side effects, like liver and kidney damage, especially if you drank alcohol while you were taking the drug for your cholester-ol. Also on the potential side effects menu was pancreatitis.

So maybe you didn't want to take Lipitor® and your doctor could prescribe another medicine to fight high cholesterol, like Crestor®.

Rosuvastatin was the name of the drug. Besides lowering your cholesterol, and to show it is every bit as side-effect effective as Lipitor® you can enjoy the side benefits of nausea, headache and constipation, and that's just the appetizers.

The really bad stuff was pretty much the same as Lipitor®, pancreatitis, liver damage, kidney damage.

Right about now, high cholesterol isn't looking all that bad as a condition, so let's go take a look at another common health problem big pharma loves to prescribe for — high blood pressure.



As of 2022, there are 7.9 billion people living on Earth — an especially astounding fact when you consider that a little over two centuries ago, the planet crossed the 1 billion mark for the first time. Studying global population trends isn't just a fascinating endeavor — understanding the growth (or decline) in the Earth's populations helps researchers to better predict conditions in the future. From the most-populated continent to a municipality with just one person, here are 13 fascinating world population facts that may surprise you.



# The Majority of Earth's Human Population Lives in One Hemisphere

Although the Earth's hemispheres are equal in geographic size, the Earth's population is not divided similarly. Roughly 90% of Earth's human population lives in the Northern Hemisphere, which also accounts for most of the planet's landmass. The Northern Hemisphere is made up of 39.3% land (the rest is ocean) and also contains many of the world's most-populated cities, while the Southern Hemisphere only is 19.1% land.



## Over Half of the World's Population Lives on a Single Continent

Earth's continents are similarly unequal in population distribution—it's estimated that 60% of Earth's population (4.7 billion people) lives in Asia. Made up of 48 countries, Asia is also home to the two most populous nations in the world, China and India. China is estimated to currently have 1.44 billion people living in the country, while India is not far behind with an estimated 1.40 billion residents. Together, the two countries account for over half of Asia's total population.



## Japan Is Home to the World's Most-Populated City

China and India may be the nations with the highest population, but Japan is home to the most populated city. In 2022, the population of the Tokyo metropolitan area is estimated to be an astounding 37.7 million people, with 13.96 million living in the city itself. To compare, greater Tokyo's population is almost equivalent to the total sum of the 25 most populated cities in the U.S., which adds up to 37.8 million people. It's also 1.5 times larger than the next most populous metro area, Seoul.

## Monaco Has the World's Densest Population

Monaco may be the second-smallest country by geographical size, but it does have the world's densest population. With a population of 39,000 people spread across just three-quarters of a square mile, Monaco has a population density of about 50,000 people per square mile. If you were to consider both independent countries and territories, the Chinese territory of Macau is even more dense, with over 51,000 people per square mile.



## Katy, Texas, Has the Most-Populated ZIP Code in the U.S.

California might be the most-populated state in the U.S., but Texas is home to the most populated ZIP code. The Texan ZIP code of 77449 has a population of 128,294 people and belongs to Katy, Texas, a suburb located 30 miles west of Houston. ## 6 Coffee Drinks, Explained

Food & Drink

The world's love affair with coffee seemingly knows no bounds. Beginning in 13th-century Arabia and later migrating across the globe, coffee — and coffee culture — has shaped the way we work, socialize, and savor our daily rituals. Today, gournet espresso drinks are an important piece of many people's lives, often multiple times per day. But with so many different beverage choices, how do you choose what to order? What's the difference between a caffè latte and a flat white, and how can you know which drinks are petite pick-me-ups and which are more, ahem, grande? Here are six captivating, caffeinating explanations of well-known espresso drinks to sort it all out.



## What's an Americano?

The humble Americano is a product of World War II, born of American soldiers' attempts to recreate their good old cup of joe from





back home while they were stationed in Italy. The "black coffee" of espresso drinks, the caffè Americano is just water and espresso. It contains no dairy or plant milks, and the ratio is usually one-third espresso to two-thirds hot water — although some serve it with half espresso and half water. To make this drink, one must first pour the espresso, and then add the water. Ice can be added to serve it cold. The Americano's close cousin, the long black, is served in Australia and New Zealand, and it's a slightly stronger beverage, due to the espresso being poured second.



## What's a Latte?

Latte means "milk" in Italian, so this drink is aptly named. In most coffee shops, if you order a caffè latte — or "latte" for short — what you'll get is two shots of espresso poured into between 4 and 6 ounces of steamed milk. (If you order a larger size, you'll get more steamed milk added, but the amount of espresso will stay the same unless you request an extra shot, that is.) Coffee has been commonly taken with cream or milk, either steamed or unsteamed, in Europe since at least the 17th century. But the modern latte we know today was established on the West Coast of the U.S., starting out on the menu at the historic Caffe Mediterraneum in Berkeley, California, in the 1950s and later popularized in cafes throughout Seattle, Washington, in the '80s. Depending on the barista, your latte may have a small amount of foamed milk added to the top — and you may even receive a pretty design in the foam, if they're skilled at latte art. Just don't order a "latte" when in Italy — if you don't use its full name, caffè latte, you might end up with a regular glass of milk!



## What's a Mocha?

Are you a chocolate fan? Well, a mocha is just a latte with chocolate in it, usually in the form of either cocoa powder mixed with sugar or chocolate syrup. Its name alludes to the port city of Mokha, Yemen, an early center of the coffee trade starting in the 15th century. As the story goes, the beans from Mokha were said to have an element of chocolate in their flavor and tone, and eventually, around the turn of the 20th century, people just started adding the chocolate themselves. A caffè mocha — or just "mocha" for short — is traditionally served in a glass rather than a mug and is frequently topped with a dusting of cinnamon. Because it has added sugar, some people consider the mocha a dessert rather than a breakfast drink, but be careful — because it contains chocolate, a mocha can contain significantly more caffeine than other coffee drinks, so it may not be the best choice before bedtime.



## What's a Flat White?

The flat white comes to us from New Zealand (though some say Australia), and it's essentially a more intense latte with a thinner layer of foam. (Or a "flatter" layer, as some might describe it; the name may also come from the unique type of foam the drink uses, as

it's flatter than the super-airy foam in, say, a cappuccino.) The flat white is only about 6 ounces total, so it's a smaller, shorter drink than a latte, which is lengthened with more milk. This gives the flat white a more powerful espresso flavor, thanks to the higher coffee-to-milk ratio. To make a flat white, start with a heatproof glass, pour in a single or double shot of espresso, add about 4 ounces of steamed milk, then cap it with "microfoam," which is made at a lower temperature, in a thin layer to the top of the beverage. This special microfoam has smaller, tighter bubbles that impart a more velvety feel, which contributes to the creamy overall mouthfeel of the drink. The popularity of the flat white in the U.S. jumped significantly around 2010, and now they're such a standard part of the American coffee repertoire that you can even order them at Starbucks.

foam is often lightly dusted with cinnamon, while in Australia, New Zealand, and the U.K., cocoa is used in this way. Fun fact: In Italian, cappuccio means "hood," which is how the monks themselves got their name, thanks to this feature of their distinctive robes.

## What's a Cortado?

The cortado originates in Spain — the word cortado means "cut," because it's an espresso that's been cut with warm milk. This is a mini-drink, usually around 4 ounces, intended as an afternoon pickme-up, often accompanied by a pastry or some other snack. It's simple to make, too: A cortado is half espresso and half steamed milk, usually 2 ounces of each, and it's typically served without sugar. If you prefer your coffee a little sweeter, you can opt for the Cuban version, the cortadito, with a dab of sugar or sweetened condensed milk added.

## What's a Cappuccino?

Named in the 19th century after the tan-and-white robes of Rome's Capuchin monks, a cappuccino is about balance. It's a trinity of espresso, steamed milk, and foamed milk — a third of each, layered in the cup, in equal amounts — served in a ceramic cup that's a little wider and flatter than the usual coffee mug. The result is a rich drink, usually only 3 or 4 ounces in volume, with low acidity, a strong espresso flavor, and a mild sweetness from the milk. To correctly drink a cappuccino, one should not mix the elements together and instead sip it as is, with a visual demarcation between the ingredients, so that each flavor can be tasted separately. Although a cappuccino is usually served unsweetened, in the United States, the milk
